WORKING RESULTS :

During the year under review, the company has registered an increase of 5% in sales of malt, but due to tough competition in the market, the selling price of malt could not absorb the increase in total cost of malt resulting to fall in profit before tax from Rs.21.74 lac (besides profit on sale of surplus land of Rs.1187.36 lac) in the immediately preceding year to Rs.0.28 lac during the year.

Your directors are making utmost efforts to improve the sales/production during current year to improve the profitability of the company barring unforeseen circumstances.

DIVIDEND:

Due to loss for the year, your Directors express their inability to declare any dividend for the year (previous year nil).

DIRECTORS:

Shri D.S. Yadava a Director of the Company will retire by rotation on the conclusion of 59th Annual General Meeting in accordance with the provisions of Articles of Association of the Company and the Companies Act, 1956 and being eligible, offer himself for re-election.
