As per the technical analysis of the stock, it is evident from the above chart that the stock was trading in consolidation phase from some previous trading sessions before given a clear brakeout on downside on the last two trading sessions with good volumes.. On the daily chart the candle pattern formed is a strong black candle. The daily RSI is trading at 66 indicating further downside momentum .MACD is giving bearish indicaton . On the Weekly Charts as well the STOCHASTIC OSCILLATOR is trading at 78 with negative bias. The MACD is turned from neutral to bearish. We recommend the investor to maintain short position in the stock. The entry range would be 540-42 and it is advisable to follow the stop loss 560.

It is evident from the Chart that the stock has continuing its northward journey .The RSI which is at 61 with positive bias. Leaves much scope for the upside movement in the price levels.The Stock is trading above 9 and 18 days EMA.The Fact is further supported by MACD which has witness bullish crossover. In the weekly chart also STOCHASTIC OSCILLATOR is trading at 24 with positive bias supported by heavy volumes . The candlestick formed on the weekly chart is white candle reflecting bulls won over bears. We recommend the investor to maintain the long position in the stock. The entry range would be 1215-18 and we advise to follow a strict stoploss of 1195.
