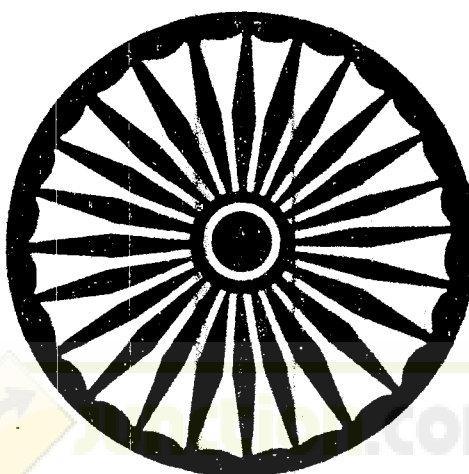

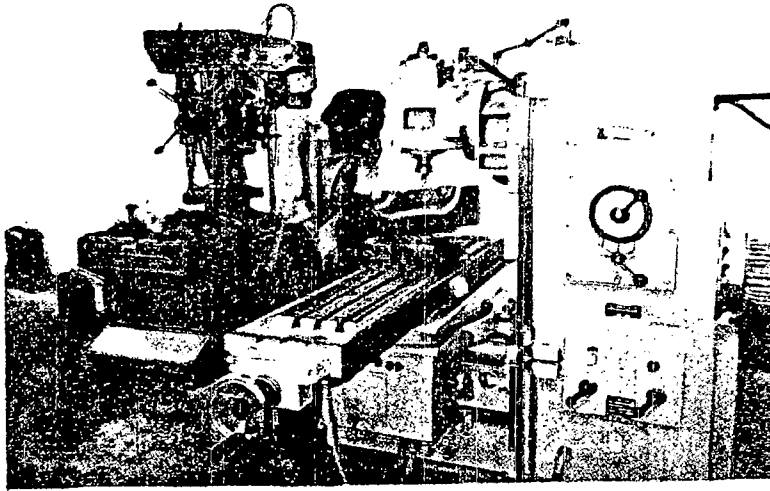

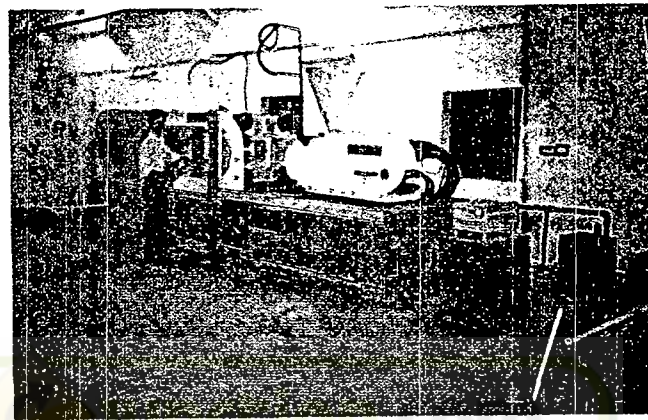

Your Directors have pleasure in presenting the 5th Annual Report and Audited accounts for the year ended 31st March, 1997.

DIVIDEND :

In view of the loss during the year, The Board of Directors do not recommend any dividend for the year.

OPERATION :

The turnover of the Company for the period under review is Rs. 90.52 lacs as against Rs. 42.08 lacs in the previous year thereby registering an increase of 115.11%.

During the year under review, the company has incurred net loss of Rs. 9.95 lacs as against Rs. 0.35 lacs profit in the previous year which was due to conversion of capital work-in-progress into fixed asset during the year resulting to a higher amount of depreciation, Capitalisation of Preliminary and pre-operative Expenses, Higher interest charges and increase in the staff on production department.

CURRENT YEAR WORKING :

Working results for the current year are expected to be better as compared to those of the previous year. The Company has successfully set up dealer net work all over Gujarat and M. P. The Company is in the process of setting up dealer net work in the state of Rajasthan, Maharashtra, Karnataka and Andhra Pradesh. The Company has already acquired Marketing office at Rajkot in the state of Gujarat for Saurashtra region.

The Company has confirmed export order for supply of Sprayers worth Rs. 6 Lacs from Tanzania. The Management of the company is concentrating their efforts to push up the Company's products in other African countries. The Company is expected to achieve export turnover of around Rs. 20 lacs during the current year.

The Company has applied for ISI mark registration which is under consideration. On getting ISI licence the company will be able to sell five brands of its product under State Government Subsidy Scheme thereby turnover of the Company will increase.

DIRECTORS :

Smt. A. R. Patel and Shri R. A. Patel retire by rotation at the ensuing Annual General Meeting and being eligible, offer themselves for re-appointment.

FIXED DEPOSITS :

The company has not accepted any fixed deposits from the public during the year under review.
