- b) Long Term Loans from EXIM Bank, which is secured by First charge on Fixed Assets by way of mortgage of immovable fixed assets and hypothecation of movable Fixed Assets excluding specific Fixed Assets charged to Working Capital bankers and personal Guarantee by some of the Directors. Corporate guarantees by Bombay Minerals Ltd. and the First Pari-passu charge on entire movable and immovable Fixed Assets of Bombay Minerals Ltd. also pledge on entire equity shares of Bombay Minerals Ltd.

(Due within one Year Rs. 588.47 Lacs; previous year Rs.639.64 Lacs.)

- c) Term Loan from Bank of India, which is secured by hypothecation of Plant & Machinery proposed to be purchased out of term loan and equitable mortgage of land and building for the baraya project.
- d) Term Loans from banks against hypothecation of vehicles. (Due within one Year Rs. 6.85 Lacs)

2) Working Capital Finance includes :

- a) Pre-shipment credit from EXIM Bank, which is secured by an exclusive charge over Current Assets created from the loan, including contract receivable, pertaining to the contract, Personal Guarantees by some of the Directors, extension of charge over assets exclusively charged to EXIM Bank for existing loans.
- b) Exports Packing Credit Finance and Post-shipment finance from banks, which are against hypothecation of inventories, book debts and secured by discounting of export bills and personal guarantees of some of the directors and further secured by equitable mortgage of fixed assets of the company.
