BEARING INDUSTRY REVIEW :

While the Indian Industry in general continues to face recessionary condition such as reduced rate of growth, slow down in demand and liquidity shortage, bearing industry in particular showed no signs of recovery during the year under review. It continues to be one of the worst hit industries facing combined adverse impact of general recession as well as unhealthy competition from unfairly cheap imports of bearings.

Y2K COMPLIANCE :

The Company had taken necessary steps to assure/secure Y2K compliance of the equipments and software deployed in the company's operations. The Company has not experienced any problem in the change over to the Year 2000

OPERATING RESULTS :

The sales during the year were Rs. 3015/= lacs as against Rs. 3404/= lacs in the previous year. The keen competition in the trade and the recessionary trend prevailing in the market, effected much to the operating profit of the Company during the year under review.

DIVIDEND :

Considering the position of the Bearing Industry and the Company, the Board of Directors regrets its inability to recommend dividend for the year.
