Operations

Sheet Metal Division

The economic slowdown affecting industry in general resulted in severely decelerated demand in the commercial vehicle sector over the past two years.

The decline in demand witnessed in the later half of 1997-98 continued right through 1998-99. The Company's operations thus suffered a serious set back in 1998-99, particularly since the company had created additional capacity in the pressings division to cater to the enhanced demand realised upto 1995-96 and forecast for 1996-97.

1997-98 Demand however shrank by 35% over 1996-97 levels, which coupled with the additional capacity created meant a nett capacity utilization of just about 25% in the year under review. Obviously, therefore, the investments made in plant and machinery and the support systems created were grossly underutilized.

The reduced off-take was fragmented further exerting extreme pressure on prices and margins by smaller units situated in and around vehicle manufacturers who, in pursuit of their survival, offered price cuts leading to an artificial competition.

Meeting Customer demand of 'Just in Time' supplies through the Company's warehouse in Pune additionally escalated the cost of delivery considerably.

Countering this, the Company has been working towards cutting costs and enhancing value addition vigorously. Simple pressings being supplied to Telco are being converted into subassemblies with additional components and so far, supply of 10 such assemblies have been productionized.

To enhance capacity utilisation the Company has also taken up various product developments a brief summary of which is given below.

A) Air Suspension System

The Company has received Govt. of India approval, for a technical collaboration agreement with Neway Anchorlok International Inc., Muskegon, USA to manufacture the NAI branded Air Suspension Systems in India. These are widely used in Commercial Vehicles, Buses and Trailers to provide a cushioned air ride and reduce transporters' operational costs. NAI is a 50 year old air suspension pioneer in USA and has 60% of the Truck, Trailer and Bus air suspension market in the USA. NAI also has a considerable global market share in Air Suspension System supply particularly in Europe and Pacific rim countries. Commercial production of Air Suspension systems is expected to commence in October, 1999. The products will be offered to individual customers, in addition to offering them as original fitment to interested OEMs. Talks are on with leading OEMs to offer them the systems for fitment in the vehicles being manufactured in the country. The Company sees considerable sales potential in this advanced technology product in the years to come.

B) Oil Pan & Bed Plates for TATA Cummins

The Company has been working with Tata Cummins Limited for sometime now on the development of Oil Pan, which for the Cummins Engines, is an import substitute. Most of the teething problems have now been resolved and regular supplies started. With Telco's plan to implement 100% fitment of Cummins engines on their vehicles by the year 2000, at full demand, this is expected to open up significant opportunities for substantial business enhancement.

- C) The Company has also entered into an Memorandum of Understanding with Piaggio Greaves Vehicles Ltd. to fabricate and supply complete delivery cab for their modern range of three wheeler delivery vehicles. This will utilize a major portion of the present pressings capacity at the Jejuri unit of the Company. The Pressings capacity at Jejuri will be further augmented by shifting existing presses from Goa reducing the transportation cost and enhancing the 'just in time' supply capability.
- D) The Company has also been holding discussions with a few other potential customers with a view to forging long time alliances offering products and services and expects a few of them to come to fruition in the current financial year.

Bus Body Division

579 Buses were produced during the year under review. The newly introduced 6HD Model buses productionised in the second quarter received an enthusiastic response and 51 buses were sold during the year under review.

The 6HD has also been appreciated in the export market and countries hitherto not in the ACGL bus sales segment have started buying ACGL buses in the new model.

The General decline in industrial and business activity and the resultant recession however affected the bus market in the year under review and this situation has not witnessed improvement in the current financial year so far. The Bus Division capacity, therefore, continues to be underutilized to a considerable extent.

The Company had in the past, with the active help and support of Telco, developed a market for ready-built buses to be sold by the chassis manufacturers off their show rooms. Abrupt changes in the Excise Rules in 1996 however, curtailed such sales considerably due to imposition of an additional burden of Excise Duties. The Company is exploring the possibility of reviving this market.

Ashiyana Auto Bodies Limited (AAL)

Ashiyana Auto Bodies Ltd. - in which your Company has invested Rs. 45.50 lacs (being 23% of the Share Capital of that Company) has suffered serious set backs due to the extremely low demand for the mini buses during its first full year of production. The Company has extended full help and support to the fledgling Ashiyana Auto Bodies Ltd as it believes that the facilities created at its Satara factory are a long term investment which will help supplement the range and volume of business in the Passenger Vehicles market. Ashiyana Auto Bodies Ltd. has taken various steps to improve its business performance such as introduction of new models, DGSD registration etc. Discussions are being held with OEMs to offer them buses on their chassis produced using the upto date facilities established by AAL.

Finance

Over the last three years, the Company has invested a sum of Rs. 13 crores in land and buildings and plant & equipment, to meet the planned expansion activities. As against this, a short term loan of Rs. 7 crores was raised from ICICI Limited in 1997, which has been fully repaid by August, 1999.

To augment the long term Working Capital requirement as also to meet other capital expenditure requirements, a further term loan of Rs. 110.00 million has been arranged from ICICI Limited.

Year 2000

The Company has taken appropriate steps to ensure that all its computerised systems are year 2000 compliant.

Further, the Company has also drawn up suitable contingency plans to meet any eventualities arising out of year 2000 problem in its systems.
