

DIRECTORS' REPORT TO THE MEMBERS

Dear Members.

Your Directors submit Sixteenth Annual Report together with the Audited Statement of Accounts for the year ended 30th June, 2000

FINANCIAL RESULTS

Income from sales and other sources during the year under review amounted to Rs.18.02 lacs. Loss after interest (Rs 11.45 lacs.), depreciation (Rs.3.99 lacs), share issue expenses (Rs. 1.93 lacs) for the year under review was Rs 16.27 lacs against Rs.24.68 lacs in the previous year. The accumulated loss of Rs.151.40 lacs has been carried to Balance Sheet.

REVIEW OF OPERATIONS

Trend of recession in India has continued and the impact is felt by every sector, Even IT Sector which was looking positive due to Internet and e-commerce is caught on wrong foot. Your company has faired better than previous year but not fully recovered due to overall weak financial scenario in the Country.

CURRENT YEAR

Current year has retained the upward curve but not getting the true momentum to make the bottom lines better. Government intent to tackle the recession and push IT sector ahead may improve the business in the current year. Some new Corporate clients are expected to improve the sales.

FUTURE

Your Company has already tied-up to work more intensely in "Medical" and "Internet" field with other developers and there product will be promoted by Abacus through direct sales and also through Internet. Management is having serious discussion with few major clients for bulk sales of our products. Even "Wipro" has started offering "Sulipi", an Abacus product with their Printers and Management is confident to clinch similar deals in near future from other such corporate giants

DIRECTORATE

Shri U.J.Ghelani, Director would retire by rotation at the ensuing Annual General Meeting and is eligible for re-appointment. AUDITORS OBSERVATIONS

The notes in Schedule "L" and in particular notes 1(d), 1(e), 2, 8 and 9 and 11(ii) which form part of the Accounts provide adequate explanation on matters referred to in the Auditors' Report to the members namely, non-provision of bonus gratuity liability, doubtful debts, doubtful advances and managerial remuneration. Steps are being taken to deposit PF & ESIC and Sales tax with the concerned authorities.
