During the year under consideration, your company achieved a turnover of Rs. 3401.92 lakhs as against Rs. 4226.21 lakhs for the previous year. The net Profit after tax at Rs. 63.44 lakhs was lower as compared to the Previous year of Rs. 106.82 lakhs.
