#### 2. OPERATIONS

Turnover and Miscellanous income for the year under reveiw has reduced to Rs. 104.07 Lacs as compared to Rs. 568.35Lacs of previous year due to lower capacity utilisation of both SSP and Acid Plants. The Company has suffered a loss of Rs. 535.51 Lacs as Rs. 473.20 of the last year.

The Company has been declared a sick Industrial Company within the meaning of Section 3(1) (0) of the Sick Industrial Companies (special provision) Act 1985 by Board for Industrial and Financial Reconstruction (BIFR) with hearing held on 23rd March, 1999. Industrial Finance Corporation of India has been appointed the Operating Agency to prepare the Draft Rehabilitation Scheme under Section 17(3) of this Act

### 3. SICK COMPANY

The Company has been Registered with Board of Industrial and Financial Reconstruction as a Sick Industrial Unit as Case 1., 290/98 on 29 October, 1998.

#### 4. DIRECTOR

Sh. Ravinder Krishan and Sh.Sajjan Singh Dhillon,Directors of the Company retire at ensuing Annual General Meeting and being eligible offer themselves for reappointment. Sh.Bhupal Singh Ghuman has ceased to act as director of the company. Sh. G.S.Sodhi, has been appointment as whole time Director w.e.f. 1st June, 1999.
