The Directors are pleased to present their Twelfth Annual Report and the Audited Statement of Accounts for the year ended 31st March, 1997.

2. DIVIDEND

Your Directors are pleased to recommend a dividend of Rs.0.90 ps. per share for the year ended 31st March, 1997. The proposed dividend, if declared at the Annual General Meeting will absorb Rs.29.14 Lakhs (Previous year Rs 42.10 Lakhs).

3. OPERATION

The Sales during the financial year rose to Rs.2318.29 lakhs as compared to Rs.1799.46 lakhs in the previous year registering an increase of over 29%. However, the Net Profit of the Company decreased to Rs. 131.81 lakhs due to increase in operational cost, interest and administrative expenses.

4. PROJECTS

The Company has commenced the commercial Production of Meta Phenoxy Benzaldehyde (MPB) during the year under review and the implementation of the projects for the manufacture of Cypermethrine (130TPA), Fenvelerate (100TPA) and Dicholorvos (DDVP) are in process. The commercial production for the same is expected to be commence during the year of 1997-98.
