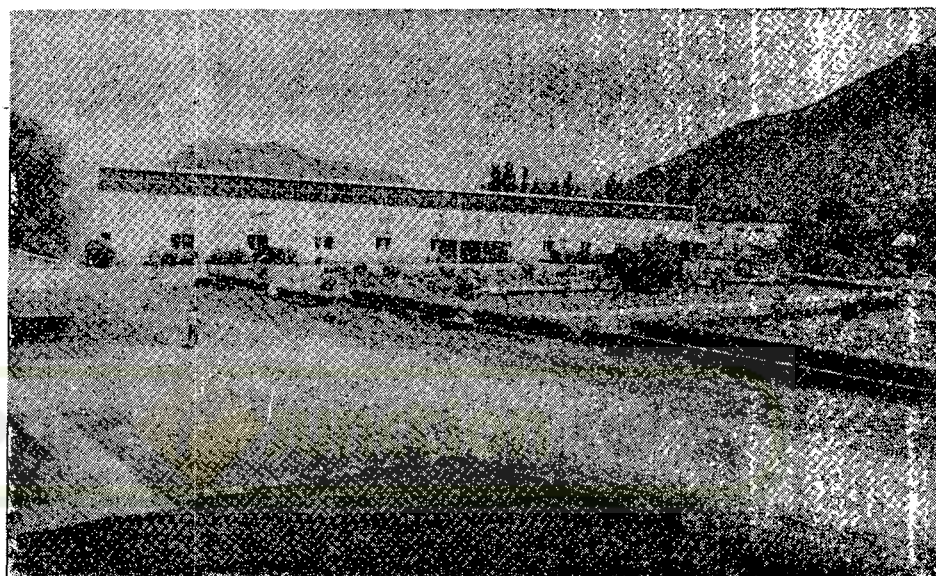

Explanatory Statement Pursuant to Section 173 of the Companies Act, 1956. Under Section 224-A of the Companies Act, 1956 the appointment of Auditors has to be made by passing a special resolution as public financial institutions hold shares in the Company exceeding 25% of the paid-up capital of the company. Hence, the re-appointment of Auditors is being made by this special resolution.

## DIRECTOR'S REPORT :

To our Share holders:

Your Directors have pleasure in presenting the 24th Annual Report of the Company with the audited accounts for the year ended 31st March, 1998.

## Working Results :

The turnover during the year has been of Rs. 302.17 lakhs compared to Rs.668.22 lakhs during previous year. The other receipts on account of export incentives, Commission etc., amounted to Rs. 4.34 lakhs during the period as against Rs.49.17 lakhs during previous year. During the year the Company has incurred net loss of Rs. 38.48 lakhs. The accumulated loss now stands at Rs. 37.31 lakhs after providing for accumulated depreciation of Rs. 111.54 lakhs. The Company has worked to 15.18% of its capacity during the current year.

The Leather Industry is still facing crisis due to recession in International and Domestic markets.

## Share Capital :

The Paid-up capital excluding the amount of Rs. 83.875 received on forfeited shares as on 31st March, 1998 stood at Rs.57,39,000.

## Fixed Deposits :

No deposits have been received pursuant to Section 58 A of the Companies Act, 1956 and there are no deposits to be repaid and/or claimed.

## Auditors:

M/s. Rowe & Pal, Chartered Accountants, Vizianagaram the Company's Auditors retire at the conclusion of the ensuing Annual General Meeting. They have signified their willingness to accept re-appointment and have further confirmed their eligibility under Section 224 (B) of the Companies Act, 1956. The members are requested to appoint the Auditors for the current year and fix their remuneration.

## Directors :

Sri A. Appanna Dora retires by rotation and being eligible offer for re-appointment.

Sri K. Nageswara Rao retires by rotation and being eligible offer for re-appointment.

## Employees :

As on the date of this report the Company has 212 individuals on pay rolls including executives.
