### ANNEXURE - 'A' TO DIRECTOR'S REPORT

# MANAGEMENT DISCUSSION AND ANALYSIS OPPORTUNITIES, THREATS, RISKS, CONCERNS AND OUTLOOK:

The consumption of chocolate is rising in developing countries like China, Korea, Argentina, Brazil etc. As a result of this the demand for confectionery fats and Cocoa Butter Equivalent is also increasing. The Company is discussing marketing of its products in these countries and is hopeful of materializing the new orders there. The Indian Government's decision to allow usage of vegetables fats in India is also in the advance stage and it will open up a good domestic market for the company. The supply of confectionery fats depend upon the crop of tree-borne oilseeds i.e. Sal, Mango and kokum and in case of a poor crop of these oilseeds in India, the company may face problem in supplies of its products from the suppliers.

#### **EXPORTS:**

Considered as main thrust area of growth as the Company's brands are gaining acceptability in major markets.

### PERFORMANCE OF THE COMPANY:

Performance of the Company was not as expected because of depressed market conditions and competitive market.
