#### ANNEXURE TO THE NOTICE

Explanatory statement pursuant to Section 173(2) of the Companies Act, 1956.

#### Item No. 6 to 9

Resolution No. 6,7,8 and 9 to the Notice relate to the approval to the terms of re-appointment and terms of remuneration of Shri Seva.ntilal P. Shah as Chairman & Managing Director, Shri Dinesh S. Shah as Managing Director, shri Pankaj S. Shah as Jt. Managing Director and Shri Bhupendra S. Shah as Director (Taxation).

Shri Sevantilal P. Shah was appointed as Chairman & Managing Director by the Shareholders of the Company at the Extra-Ordinary General Meeting held on 12th October, 1992 on the terms and conditions as specified in the agreement submitted there at.

Shri Dinesh S. Shah was appointed as Managing Director and Shri Pankaj S. Shah was appointed as Jt. Managing Director at the Board Meeting held on 29th June, 1992 by the Board of Directors of the Company on the terms and conditions as specified in the agreement submitted thereat.

Shri Bhupendra S. Shah was appointed as Director (Taxation) by the Shareholders at the Annual General Meeting held on 14th August, 1992 on the terms and conditions as specified in the agreement submitted thereat.

Schedule XIII of the Companies Act, 1956 has since been been amended by the Central Government vide Notification No. 510(E) dated July 14, 1993 and Notification No. G. S. R. 48(E), dated February 1, 1994. Accordingly the material terms of remuneration payable to Shri Sevantilal P. Shah, Chairman & Managing Director, Shri Dinesh S. Shah, Managing Director, Shri Pankaj S. Shah, Jt. Managing Director and Shri Bhupendra S. Shah, Director (Taxation) in accordance with para - II of the Schedule XIII of the Companies Act, 1956 are as under As the age of Shri Sevantilal P. Shah, Chairman & Managing Director exceeds 70, His re-appointment will be subject to the approval of the Central Govt.

#### (1) Salary:

Rs. 26000 per month in the scale of Rs. 26000-2000-36000 to Shri Sevantilal P. Shah, Chairman & Managing Director.

Rs. 34000 per month in the scale of Rs. 34000-2000-44000 to Shri Dinesh S. Shah, Managing Director. Rs. 28000 per month in the scale of Rs. 28000-2000-38000 to Shri Pankaj S. Shah, Jt. Managing Director. Rs. 15000 per month in the scale of Rs. 15000-1000-20000 to Shri Bhupendra S. Shah, Director (Taxation).

#### (2) Perquisites:

In addition to salary, the following perquisites shall be allowed to each of them.

# Category A:

#### Housing:

The House Rent allowance will be paid as per the rules of the Company but subject to maximum 50% of basic salary.

## Gas Electricity, Water and Furniture:

The expenses on Gas, Electricity, Water and Furnishing will be as per rules of the Company but subject to maximum 10% of basic salary.

#### Medical Reimbursement:

Expenses incurred for him and the family subject to ceiling of one month's salary in a year or three month's salary over a period of three years.

# Leave Travel Concession:

For him and his family once in a year incurred in accordance with any rules specified by the Company.

#### Club Fees:

Fees of club subject to a maximum of two clubs. This will not include admission and life membership fee.

Personal Accident Insurance Premium for self.

#### Medical Insurance Premium:

For him, his spouse and children in a year.

#### Category B:

#### Contribution to Provident Fund and Superannuation Fund:

Contribution to provident fund, superannuation fund or annuity fund will not be included in the computation of ceiling on perquisites to the extent these either singly or put together are not taxable under the Income Tax Act

#### Gratuity:

Gratuity payable should not exceed half a month's salary for each completed year of service.

#### Leave Encashment:

Leave encashment eguivalent to one month's salary calculated on the basis of one month's leave over eleven months' services.

Encashment of leave at the end of the tenure will not be included in the computation of the ceiling on perquisites.

## Category C:

#### Car and Telephone:

Provision of car for use on Company's business and telephone at residence will not be considered as perquisites. Personal long distance calls on telephone and use of car for private purpose shall be billed by the Company to him.

- (3) Notwithstanding anything mentioned above, where in any financial year during the currency of Director the Company has no profits or its profits are inadequate, the remuneration will have to be limited to amounts specified in Section II of Part II of schedule XIII of the Companies Act, 1956.
