To carry on in India or elsewhere the business of builders, contactors, designers, architects, decorators, furniture consultants, constructors, financers & brokers of all types of buildings and structures including houses, flats, apartment, offices, godowns, warehouses, shops, factories, sheds, hostels, hospitals, holiday resorts, shopping cum residential complexes, and to develop, erect, install, alter, improve, add, establish, renovate, recondition, protect, participate, enlarge, repair, demolish, remove, replace, maintain, manage, buy, sell, or deal in all types of movable or immovable properties including land for development, investment, or for resale and to act as buyer, seller, importer, agent, distributor, stockiest, or otherwise to deal in all types of infrastructure projects, raw materials, goods, fittings, parts, accessories, know-how, consumables, plants & machineries, tools & tackles used for the foregoing purposes and to do all incidental acts and things necessary for the attainment of the above objects.
- 2. To carry on in India or elsewhere, either alone or jointly with one or more persons, government, local or other bodies, the business to convert, improve, design, erect, establish, equip, develop, dismantle, pull down, turn to account, furnish, level, decorate, fabricate, install, finish, repair, maintain, search, survey, examine, taste, inspect, locate, modify, own, operate, protect, promote, provide, participate, reconstruct, grout, dig, excavate, pour, renovate, remodel, rebuild, undertake, contribute, assist, redesign, knitting, embroidering, reorganize, develop and to act as interior decorator, fashion designer,

architect, dress designer, cell and organ designer and to act as designer of any incoming or developed product in the market.

- 3. To promote, encourage, establish, develop, maintain, organise, undertake, manage, operate, conduct and to run in India or abroad computer training centers, data processing centers, call centers, kiosks, computer coaching classes, computer consultancy business, software consultancy and other allied activities for all sorts of services relating to computer, its maintenance, repairs, programmers & operations, for industrial, commercial, domestic, public utility, defense, government and other general customers or sections of society and to do all incidental acts and things necessary for the attainment of the foregoing objects.
- 4. To carry on in India or elsewhere the business of prospecting, exploring and to set, crush, process, excavate, dig, break, acquire, develop, survey, produce, convert, finish, load, unload, handle, transport, buy sell, import, export, supply and to act as an agent, broker, stockiest, distributor, consultant or other wise to deal in all sorts or Brass, Antimony, Lead, Metal & Metal Products, Nickel, Magnesium, Zinc, Tin, Gum Metal, Lead Bronze, Phosphor Bronze, Aluminum Bronze, Phosphor Copper, Copper Iron, Cupper Nickel, Alloys, Ingots, Castings & Bronze Ingot, Gold, Aluminum, graphite, granite, lead, Limestone, Mica, Nickel, Porcelain, Potash, Sand, Brass, Silver, Stoneware, Tin, Titanium, Bronze, Zinc, Uranium, Copper and other allied materials, by-products, mixtures, blends, residues, substances and to do all incidental acts and things necessary for the attainment of the above objects.

The Members BAFNA SPINNING MILLS & EXPORTS LIMITED

The Directors' have pleasure in presenting the sixteenth Annual Report of the Company and the Audited Statement of Accounts for the year ended 31st March 2007.

Your Directors also wish to inform you that the formalities for revocation of suspension of trading of shares at The Stock Exchange, Mumbai have been complied with and is expecting the revocation of suspension at the earliest. The Listing Fees payable to The Stock Exchange has been paid till March 2007.

1. FINANCIAL HIGHLIGHTS:

Your Company during this financial year has started trading activities in Textiles. The Company has also proposed to amend the Memorandum of Articles which has been placed for the consideration of you the shareholders of the Company. The Company sees an opportunity in the Reality Business and hence this proposal. The Company is in the process of concluding a tie up with a Reality based Company in North India to start its activities in Southern India. Your Directors hope to sign the MOU before the financial year end.

2. DIVIDEND

As the commercial production is yet to be started, your Directors regret that no dividend is declared.

3. DIRECTORS:

Mrs Uma Bafna retires by rotation at the ensuing Annual General Meeting and being eligible offers herself for re-appointment. Your Directors recommend her re-appointment.

4. AUDITORS REPORT:

5. AUDITORS:
