**Year under Review:**

During the year under review, your Company earned total Income of Rs. 892,100/- comprising mainly of dividend income. Against this, the total expenses amounted to Rs. 33,414/- incurred by the Company. This has led to a profit of Rs. 858,686/- as compared to a profit of Rs. 866,091/- before tax during the previous year. After adjusting thereto the balance of profit forward from last year of Rs. 1,381,066/-, a balance of profit of Rs. 2,239,752/- has been carried forward to the Balance Sheet.

Your Company continues to be cautiously optimistic about its growth prospects for the current financial year.

Your Directors do not recommended any dividend for the year under review.
