ANNEXURE REFERRED TO IN PARAGRAPH 1 OF OUR REPORT OF EVEN DATE ON  
THE ACCOUNTS OF BIJOY HANS LIMITED FOR THE YEAR ENDED 31ST MARCH 2000:

- i) The Company has maintained proper records showing full particulars including quantitative details and situation of Fixed Assets. A physical verification of the assets has been conducted by the Management at the year end and there were no serious discrepancies between the physical assets and the assets as per records. In our opinion, the programme of verification carried out during the year is reasonable having regard to the size of the company and the nature of the Assets.
- ii) None of the fixed assets have been revalued during the year under audit.
- iii) The stock in trade were physically verified by the Management during the year at reasonable intervals.
- iv) In our opinion, the procedure for physical verification of stocks followed by the Management are reasonable and adequate in relation to the size of the Company and the nature of its business.
- v) No discrepancies were noticed on physical verification of stocks as compared to book records during the year under audit.
- vi) There was no stock in trade at the beginning as well as at the end of the year under audit.
- vii) The Company has not taken any loans from Companies, Firms and other parties required to be listed in the Register maintained under Section 301 of the Companies Act, 1956. As explained to us, there are no companies under the same management as defined under Sub-Section (1B) of Section 370 of the Companies Act, 1956.
- viii) The Company has not granted any loans, secured or unsecured to Companies, firms or other parties listed in the Register maintained under Section 301.
- ix) No loans or advances in the nature of loans have been given by the Company during the year under audit.
- x) In our opinion and according to the information and explanations given to us there are adequate internal control procedures commensurate with the size of the Company and the nature of its business for the purchase of Stores, raw-materials including Components, plants and machinery, Equipment and other assets and with regard to sale of goods.
- xi) In our opinion and according to the information and explanations given to us, no purchases of goods and materials and no sales of goods, materials and services aggregating to Rs. 50,000/- or more in respect of each party have been made during the year under audit in pursuance of contracts or arrangements entered in the Register maintained under Section 301 of the Companies Act, 1956.
