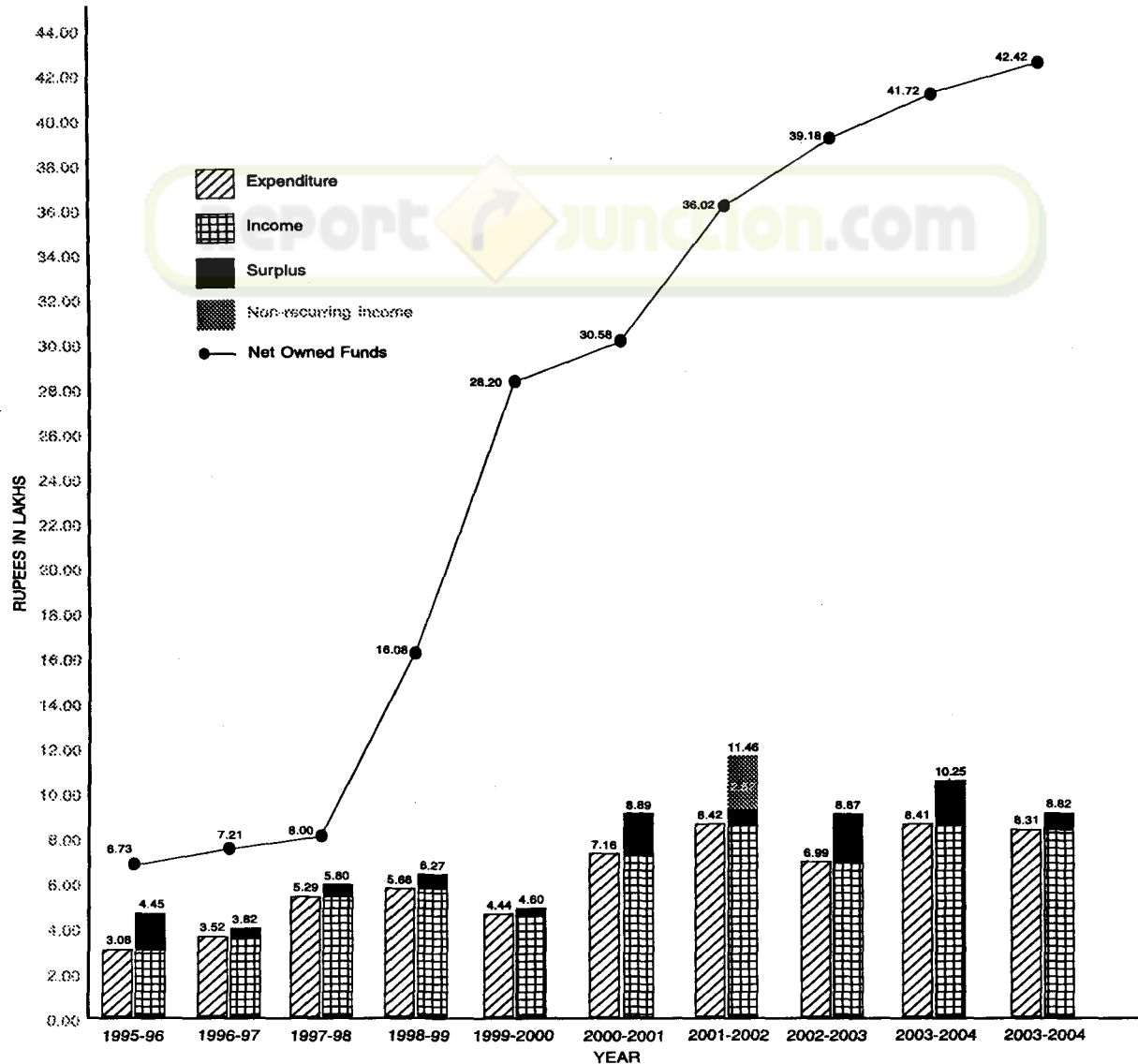

**MEMBERSHIP GROWTH CHART**





### MINUTES OF THE 22<sup>nd</sup> ANNUAL GENERAL MEETING HELD ON 28<sup>th</sup> AUGUST, 2004 AT SHRI NARANJI SHAMJI MAHAJAN WADI, MATUNGA

### ii) SUGGESTIONS FROM MEMBERS

On Invitation from President, following Past Presidents, members and students gave their suggestions as noted below:

1. Vishal V Gada                      He said that the Association is of great help to members and plays crucial role by giving platform to members. Showing concern about future role of the association in view of the new members opting for industry rather than traditional practice and also due to CPE requirement and change in profession as a whole, he stated a lot of interaction, brain storming is required to determine the future needs of members.
2. Dinesh D Ghalla                      He complimented Shri Rajesh R Shah for his efforts throughout the year. He reiterated the views of Vishal Gada and said that looking at the trend, fewer students are opting for CA profession and accordingly role of Students Committee may have to be altered. He showed concern that for the first time three members of Managing Committee (due to their personal reason) not continuing in the Committee.
3. Atul C Bheda                              He said that due to new members opting for industry, bondage of members of the association is reducing. He suggested that more and more efforts are required to see that more CAs become members of the Association. He also suggested to form study group on ISA as this is new area of practice having lot of scope and beneficial to all members in practice as well as industry.
4. Sanjeev D Lalan                              He said that the traditional area of practice is not drying up as thought but only approach of the members needs to be changed so as to become overall business consultant rather than just tax consultant. Also it is needed to have pragmatic approach in interpreting laws. He said that Association has to do perspective planning keeping in mind WTO commitments and other developments.
5. Haresh K Chheda                              He congratulated Rajesh Shah for a successful term. He suggested that Association needs to form a Vision Committee to discuss future course and focus area of Association considering CPE requirement etc.
