

Chairman's Message

Dear Shareholders.

All of us are passionate about growth...growth that empowers us to ascend new heights, that instils new confidence and determination to achieve the impossible. Last Financial year, we reached tremendous heights, in leaps and bounds. We at CTE are certain that our growth is nestled in the strong arms of stability and sustainability that has helped us take giant strides towards consistency in the direction of our corporate vision, to be the 'Single Stop Shop' for all IT services to the mid-sized organizations. Today, we can confidently say, we've achieved a perfect balance in stability and growth.

The consolidated revenues for the fiscal, FY 2007-08 were Rs.90.27 Crores (USD 22.58 Million) compared to Rs.23.40 Crores (USD 5.85 Million) of revenues for the fiscal FY 2006-07, the growth translates to over 286% year on year on annualized basis. Your company has recorded a profitability of 206% comparable with the high revenue growth.

A 286% growth in the last year is a true indicator of our achievement. We are proud of the fact that we were among the Top 3 companies at the Emerging India Awards 2008 in the ICE /IT & ITES category, jointly organized by CNBC TV - 18 and ICICI Bank. The initial responses of the India customers to the augmented CTE services have been very positive. Many exciting opportunities have been identified in the commercial and government sector in India which will be pursued in FY 2009. Further, CTE plans to expand its operation in the APAC and Europe region in the years to come.

The operations of the Company have now reached higher level of stability and growth and the outlook remains positive for the next year despite many uncertainties in the global economy. Our confidence stems from our expanded market base, extended services portfolio, good portion of revenue and cost being same-shore/ same-denomination and a balanced revenue composition between Government and Commercial segment.

Our cutting edge thinking and methodological approach towards business transformation by aligning business with IT, people and processes around untapped organizational assets has paid-off in a big way, even as our model of innovation through executive workshops with expertise from MIT and Harvard, has given us greater advantage. Also, our focus on mid-sized entities has enabled us to create an exclusive space for ourselves in the IT domain.

With future acquisitions in mind, we have reorganized our corporate structure and restructured our execution model to build a solid platform to realize our aggressive growth plans. This restructuring is aimed at consolidating operations, optimizing core delivery operation, and reorganizing sales/business development to sell one-stop-shop solutions to mid-size commercial and government enterprises.

When it comes to people, we have one of the lowest attrition rates in the industry in the mid-size space. The immense talent, dedication, commitment and support of our employees across the globe are one of our greatest assets.

I am immensely pleased to acknowledge the effort of the Team CTE, my colleagues on the board and all others who have not only believed, but also worked towards our motto..."Think Big...Start Small...Scale Fast".
