REVIEW OF OPERATION

Your directors glad to inform you that your company's performance has shown considerable improvement during the last year. The growth in performance is largely attribute to the proactive measures employed.

FIXED DEPOSITS

During the year the Company has reduced its liabilities of Public Deposit by Rs. 42.89 Lacs out of its due of Rs. 136.17 Lacs. There were matured deposits amounting to Rs. 93.47 lacs of which part have been paid as per the order of Hon'able Company Law Board and the balance are pending as requisite documents have not been submitted with the company, the company has not accepted any deposits from the Public during the year pursuant to the provisions of Section 58A of the Companies Act, 1956 under review

FOREIGN EXCHANGE EARNINGS AND OUTGO

The Company had no foreign exchange earnings/outgo during the period under review.

AUDITORS REPORT

Our comments on the obsercations made by the auditors are as under:

- Liabilities related to Rural Electrification Corporation Ltd. and Fixed deposits are sub-judice and amounts payable towards interest are not determinable at this stage. Hence they have not been provided for.
- Provisions for Non-performing assets and diminution in value of investments have not been made as in opinion of the Board, the amounts of non-performing assets are realizable at value stated in the

Balance Sheet and the value of the investments is expected to increase in view of recent upturm of capital markets.

- 3. Depreciation on Wind Power Project has not been provided, as the plant was non-operational during the whole year.
- 4. The Company is in process of obtaining Group Gratuity policy from Insurance companies for its employees in the current year, Hence, provision for the gratuity has not been made.

PARTICULARS OF EMPLOYEES

None of the employees of the Company was in receipt of remuneration in excess of limits prescribed under Section 217 (2A) of the Companies Act, 1956. Hence, particulars as required under the Companies (Particulars of Employees) Rules, 1975 are not given.

DIRECTORS:

Shri Kailash Purohit Director of the Company retire by rotaiton being eligible after himself for re-appointment.
