3. BUSINESS REVIEW & FUTURE PROSPECTS

Principal business of the company remains temporarily suspended due to unavailability of sufficient resources. Company shall restart its business immediately upon generating required resources for effective working. In order to open up choice of business, your company has liquidated its assets, vide authority granted by the shareholders by postal ballot, results of which were declared on 20-1-2005. The funds generated there from are currently invested in interest fetching loands/deposits. Company has a positive net worth. Company has meager liability, which will be met out of the liquidity generated. Your directors are evaluating various options open to the company to recommence its activities but it is difficult to predict any time frame for such success.
