

Late Shri Champraj C. Shroff

With dreams in his eyes and a vision supported by the mission to *g*enerate, *s*erve and *e*xcel, Shri C.C. Shroff, a graduate in Chemistry, established Excel Industries Ltd. in 1941 with a small capital of Rs. 10,000/- in a kitchen laboratory.

He dared to venture into a field where many feared to tread. "If something can be done elsewhere in the world, surely it can be done in India as well..! Either I will find a way or make one of mine..!" Developing more than 100 products and processes in-house, the patriotic scientist endorsed self reliance and import substitution, reflecting his firm determination, confidence and self respect; Shri C.C. Shroff was clearly a Man of Mission.


His philosophic endeavors seemed impractical and damaging to the business interests, but he strongly believed that "business does not run on profits alone, it needs the good wishes of all the stakeholders, more than profits".

"Life is like a Game of Football. The goal is right in front, there is a wide playground open to you, but your way towards the goal is blocked by eleven tough guys. They are not your enemies. Nor even your opponents. They are your competitors. It is their business to stop you. Yours is to reach the goal. The tougher the competition, the harder the game, greater the fun. And the victory." "A person who can train his subordinates so well that his own presence becomes redundant, and so he can concentrate on treading new paths" Shri C.C.Shroff personified his definition of a successful Manager-Leader.

"To live in the hearts of those who live behind is not to die", the maxim on which Shri C.C.Shroff lived, continue to enthuse and inspire the ongoing generations.

Excel humbly pays a tribute to this noble & generous soul whose guiding principles and belief continue to inspire us. The tradition of nationalism, service, conviction, values, knowledge build-up, excellence, philanthrophy, that he has left behind, is the legacy, the wealth that Excel cherishes and will continue to hold high in all times.

7. To consider and, if thought fit, to pass with or without modification, as an ordinary resolution, the following:

"RESOLVED THAT pursuant to the provisions of Sections 198, 269, 309, 310 and 311 read with Schedule XIII and other applicable provisions, if any, of the Companies Act, 1956 (as may be re-enacted or modified from time to time) and pursuant to a resolution passed by the Remuneration Committee of the Directors of the Company and subject to such other approvals as may be necessary, consent of the Company be and it is hereby accorded to the appointment of Mrs. Usha A. Shroff to the office of Executive Vice Chairperson of the Company for a term of five years with effect from 22nd January, 2008 on the terms and conditions including remuneration as set out in the draft Agreement between the Company and Mrs. Usha A. Shroff placed before the meeting and duly initialled by the Chairman for the purpose of identification."

8. To consider and, if thought fit, to pass with or without modification, as a special resolution, the following:

"RESOLVED THAT pursuant to the provisions of Sections 198, 269, 309, 310 and 311 read with Schedule XIII and other applicable provisions, if any, of the Companies Act, 1956 (as may be re-enacted or modified from time to time) and pursuant to a resolution passed by the Remuneration Committee of the Directors of the Company and subject to such other approvals as may be necessary, consent of the Company be and it is hereby accorded to the re-appointment of Mr. S. R. Potdar to the office of Executive Director of the Company for a term of three years with effect from 3rd September, 2008 on the terms and conditions including remuneration as set out in the draft Agreement between the Company and Mr. S. R. Potdar placed before the meeting and duly initialled by the Chairman for the purpose of identification."

9. To consider and, if thought ft, to pass with or without modification, as a special resolution, the following:

"RESOLVED THAT pursuant to the provisions of Section 309(4), 310 and other applicable provisions, if any, of the Companies Act, 1956, (as may be re-enacted or modified from time to time) and subject to such approvals, including of the Central Government, as may be required, so long as the Company has a Managing Director or a Whole-time Director such sum by way of commission not exceeding in the aggregate 1% per annum of the net profits of the Company, computed in the manner laid down in Section 198 of the Companies Act, 1956, for five financial years of the Company commencing from 1st April, 2007, be paid to and distributed amongst the Directors of the Company [excluding the Chairman and Managing Director, Executive Vice Chairperson and the Whole-time Director(s)] in the proportion and manner as the Chairman may, from time to time, decide.

RESOLVED FURTHER THAT if at any time during the aforesaid period of five years commencing from 1st April, 2007, the Company does not have a Managing Director or a Whole-time Director, such sum by way of commission not exceeding in the aggregate 3% per annum of the net profits of the Company, computed in the manner laid down in the said Section 198 be paid to and distributed amongst the Non-Executive Directors of the Company for the then residual unexpired part of the aforesaid period of five financial years in the proportion and manner as the Board may, from time to time, decide."

10. To consider and, if thought fit, to pass with or without modification, as an ordinary resolution, the following:

"RESOLVED THAT pursuant to the provisions of Section 293(1) (e) of the Companies Act, 1956, and other applicable provisions, if any, the Board of Directors of the Company be and is hereby authorized to contribute, from time to time, in any financial year, to any charitable or other funds or for charities or other purposes not directly relating to the business of the Company or the welfare of its employees, up to a sum of Rs. 30 lacs (Rupees thirty lacs only) or five percent of its average net profits as determined in accordance with the provisions of Sections 349 and 350 of the Companies Act, 1956, during the three financial years immediately preceding, whichever is greater."

- 1. A MEMBER ENTITLED TO ATTEND AND VOTE AT THE MEETING IS ENTITLED TO APPOINT ONE OR MORE PROXIES TO ATTEND AND TO VOTE ONLY ON A POLL INSTEAD OF HIMSELF AND SUCH PROXY NEED NOT BE A MEMBER OF THE COMPANY.
- 2. An Explanatory Statement relating to the Special Business under Item Nos. 7 to 10 as required under Section 173(2) of the Companies Act, 1956, is annexed hereto.
- 3. The Register of Members and the Share Transfer Books of the Company will remain closed from Saturday, the 23rd August, 2008 to Thursday, the 4th September, 2008 (both days inclusive).
- 4. Members are requested to notify immediately any change in their addresses to their Depository Participants (DPs) in respect of their electronic share accounts quoting Client ID No and to the Company in respect of their physical shares, quoting Folio No.
- 5. Payment of the dividend as recommended by the Directors, if declared at the Meeting, will be made on or after 9th September, 2008 to the Members whose names stand on the Company's Register of Members on Thursday, the 4th September, 2008 and to the Beneficiary Holders as per the Beneficiary List on the close of business hours on Friday, the 22nd August, 2008 provided by National Securities and Depository Limited and Central Depository Services (India) Limited.
- 6.
