In view of the continuing COVID 19 pandemic the Ministry of Corporate Affairs ("MCA") has vide its circular dated 13th January 2021 read with circulars dated 8th April 2020, 13th April 2020, 5th May 2020 and 28th December, 2022 ("MCA Circulars") Securities and Exchange Board of India vide its circular dated 15th January 2021 read with 12th May, 2020 and 5th January, 2023 ("SEBI Circular"), permitted the holding of the Annual General Meeting ("AGM") through VC / OAVM, without the physical presence of the Members at a common venue. BRIEF DESCRIPTION OF THE COMPANY'S WORKING DURING THE YEAR/STATE OF THE COMPANY'S AFFAIR:

The financial year 2022-23 was one of the most challenging years for the Indian Industry. While the Industry was on its path of recovery from a stressed working capital situation, the widespread and substantive economic disruption caused by the COVID-19 pandemic, significantly impacted the Indian industry wide performance globally as well as in India. The Summary of the company's performance is narrated as under:-

The Company has revenue of Rs. 6, 44, 24,051 as compared to Rs 14, 46, 82,726 for the previous year. The Revenue decreased by 44.53% compared to previous year.

The Total Expenditure for the period ended on 31st March 2023 amounted to Rs. 10, 93, 36,968 as compare to Rs 14, 08, 69,884 for the previous year. The Total Expenditure decreased by 77.61% compared to previous year.

The loss after tax for the period ended on 31st March 2023 amounted to Rs 4, 61, 22,728 as compare to Profit after tax Rs. 38, 12,842 for the previous year.

Your directors are hopeful to exploit the present resources in efficient manner and achieve better results in the coming year.

DIVIDEND

Your Directors have not recommended any dividend for the financial year under review in order to conserve the resource of the company.

TRANSFER TO RESERVES:

The Company does not propose to transfer any amount to Reserves for the period under review.

SHARE CAPITAL:

The issued, subscribed and paid up capital of the Company is Rs. 32, 05, 00,000/- divided into 3, 20, 50,000 equity shares of Rs. 10/- each. There has been no change in the share capital of the Company during the year.
