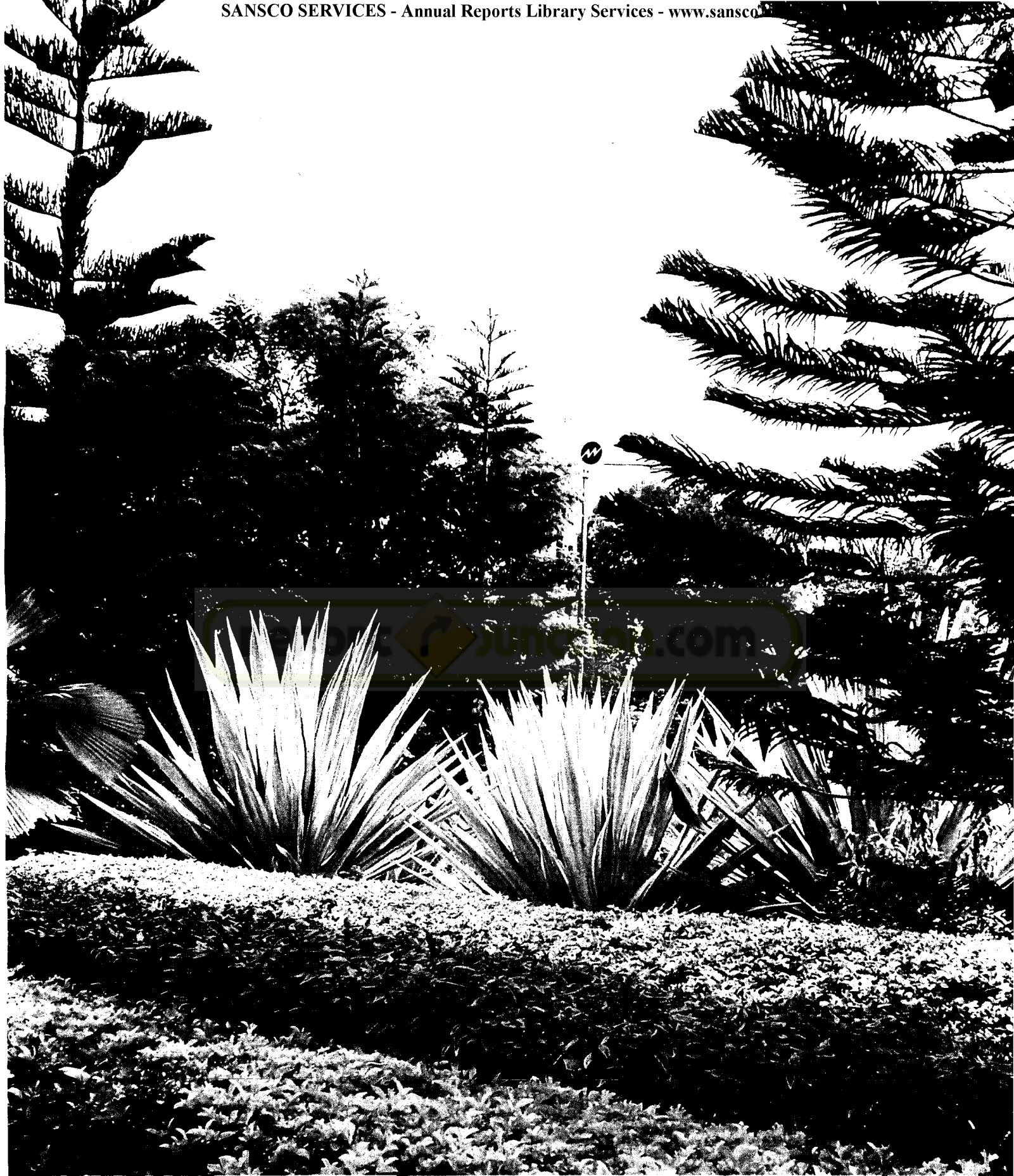

The decade dawned with the greatest war mankind has ever known, which quickly spread across Europe and South East Asia. Within India, the call for freedom reached a crescendo. By the middle of the 1940s the war was finally over and Independence was in the air. India was about to be reborn, ready to take its place in the firmament of free nations.
