Dear Partners,

We want to thank you for strengthening our resolve and helping us finish this fiscal year better than how it began.

The fiscal year started in the early days of abrupt national lockdowns, confining us to our homes and bringing commerce to a near standstill. Most of our plants were non-operational in April and May and production hobbled back to pre-lockdown levels by June and thereafter slowly returned to normalcy.

Despite the discouraging start, we ended the year producing almost as much as we did last year. Our efforts improved contribution margins by almost 2%. We stuck to our six-sigma training, eliminated waste and did more with less. With the two new plants in Mysore and Vizag ramping up rapidly, we were able to service our long-term obligations.

We continue to work with our customers, small and large, to devise ways and means that are economical and sustainable to help protect the environment. In the wake of pandemic related lockdowns we continued our CSR activities via online yoga classes and competitions. It was heartening to see that our efforts in training children in yoga at orphanages the last few years were well administered. Older children, who we have been training since 2016, were able to independently conduct sessions for the younger incoming students.

We extend our deep gratitude towards Mr. Jalaj Dani and Mr. Ashwin Nagarwadia, who retired during this financial year.

Finally, we thank all our stakeholders – employees, shareholders and customers – for their continued support.

NOTICE is hereby given that the THIRTIETH ANNUAL GENERAL MEETING of HITECH CORPORATION LIMITED ('the Company') will be held on Thursday, 29th day of July, 2021 at 2.00 p.m. (IST) through Video Conferencing ("VC") / Other Audio-Visual Means ("OAVM"), organized by the Company to transact the following businesses. - An Explanatory Statement pursuant to Section 102 (1) of the Companies Act, 2013 (hereinafter referred to as the "Act"), in respect of businesses to be transacted at the Annual General Meeting (hereinafter referred to as "AGM"), as set out under Item No. 4 above and the relevant details of the Director as mentioned under Item No.4 above as required by Regulation 36(3) of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirement) Regulations, 2015 (hereinafter referred to as "Listing Regulations") and as required under Secretarial Standards - 2 on General Meetings issued by the Institute of Company Secretaries of India, is annexed thereto.
- The Board of Directors have considered and decided to include item nos. 4 given above as Special Business in the forthcoming AGM, as it is unavoidable in nature.
- In view of the continuing lockdown restrictions on the movement of people at several places in the country, due to outbreak of COVID-19 pandemic, the Ministry of Corporate Affairs (MCA), vide its General Circular No.2/2021 dated 13th January, 2021 read with General Circular No. 20/2020 dated 5th May, 2020 read with General Circular No. 14/2020 dated 8th April, 2020 and General Circular No. 17/2020 dated 13th April, 2020 and other applicable circulars issued by the Securities and Exchange Board of India (SEBI) (the Circulars), has allowed the Companies to conduct the AGM through Video Conferencing (VC) or Other Audio Visual Means (OAVM) during the calendar year 2021, without the physical presence of members at a common venue. Hence, in compliance with the Circulars, the AGM of the Company is being held through VC/OAVM.
- As the AGM shall be conducted through VC / OAVM, physical attendance of members is not required and the facility for appointment of Proxy by the Members is not available for this AGM and hence the Proxy Form and Attendance Slip including Route Map are not annexed to this Notice.

#### 21. Procedure for remote e-Voting and e-Voting during the AGM

- All the shareholders of the Company including retail individual investors, institutional investors, etc. are encouraged to attend and vote in the AGM to be held through VC/OAVM.
- In compliance with the provisions of Section 108 of the Act read with Rule 20 of the Companies (Management and Administration) Rules, 2014 and Regulation 44 of the Listing Regulation, (including any statutory modification(s) and/or re-enactment(s) thereof for the time being in force), the Company is providing facility of remote e-Voting to its Members in respect of the businesses to be transacted at the AGM. For this purpose, the Company has entered into an agreement with NSDL for facilitating voting through electronic means, as the authorized agency. The facility of casting votes by a member using remote e-Voting system as well as e-Voting on the date of the AGM will be provided by NSDL.



- c. b) For Resident Shareholders, TDS is required to be deducted at the rate of 10.00% under Section 194 of the Income Tax Act, 1961 on the amount of dividend declared and paid by the Company in the financial year 2021-22 provided valid PAN is registered by the Shareholder. If the valid PAN is not registered, the TDS is required to be deducted at the rate of 20% under Section 206AA of the Income Tax Act, 1961.

However, no tax shall be deducted on the dividends paid to resident individuals if aggregate dividend distributed or likely to be distributed during the financial year does not exceed ₹ 5,000.

Even in the cases where the shareholder provides valid Form 15G (for individuals, with no tax liability on total income and income not exceeding maximum amount which is not chargeable to tax) or Form 15H (for individual above the age of 60 years with no tax liability on total income), no TDS shall be deducted.

c) For Non-resident shareholders [Including Foreign Institutional Investors (FIIs)/Foreign Portfolio Investors (FPIs)], the TDS is required to be deducted at the rate of 20% (plus applicable surcharge and cess) under Section 195 or 196D of the Income Tax Act, 1961, as the case may be.
