ORDINARY BUSINESS

- 2. To declare dividend.
- To appoint a Director in place of Mr.B.V.Bhargava, who retires by rotation and being eligible, offers himself for re-appointment.
- To appoint a Director in place of Mr. Leo C.O'Neill, who retires by rotation and being eligible, offers himself for re-appointment.
- To appoint a Director in place of Mr.A.V.Rajwade, who retires by rotation and being eligible, offers himself for re-appointment.
- To consider and if thought fit, to pass, with or without modifications, the following resolution, as a Special Resolution pursuant to Section 224-A of the Companies Act, 1956:

"RESOLVED THAT Messrs S.B. Billimoria & Co., Chartered Accountants, be and are hereby reappointed Auditors of the Company to hold office from the conclusion of this Meeting till the conclusion of the next Annual General Meeting on such remuneration as may be decided by the Board of Directors."

SPECIAL BUSINESS

 To consider and if thought fit, to pass, with or without modifications, the following resolution as a Special Resolution :

"RESOLVED THAT pursuant to Section 31 and other applicable provisions, if any, of the Companies Act, 1956 and the provisions of other statutes as applicable and subject to such approvals, consents, permissions and sanctions as may be necessary from the appropriate authorities or bodies, the Articles of Association

of the Company be and are hereby altered as follows:

- a) After the interpretation of "The Act", in Article 2, sub-clause 1, the following interpretations shall be inserted:-
 - The word "Beneficial Owner" shall mean the beneficial owner as defined in clause (a) of subsection (1) of Section 2 of the Depositories Act, 1996.
 - The word "Depositories Act, 1996" shall include any statutory modification or re-enactment thereof; and
 - iii) The word "Depository" shall mean a Depository as defined under clause (e) of subsection (1) of Section 2 of the Depositories Act, 1996.
- b) The interpretation of the term "Member" in Article 2, sub-clause 1 shall be amended after the words '___ Memorandum of Association' by adding the words 'and the beneficial owner(s) as defined in clause (a) of subsection (1) of Section 2 of the Depositories Act, 1996.'
- c) In Article 4 after the words '____ Register of Members' to add the words 'with the details of Members holding shares in materialised and dematerialised form in any media as permitted by law including any form of electronic media.'
- d) In Article 20 after the words '___ and from time to time.' to add the words 'Provided in case of shares held by the member in dematerialised form, no share certificate(s) shall be issued and the Company shall dematerialise its existing shares, rematerialise its shares held in the depositories and/or to offer fresh shares in a dematerialise form pursuant to the Depositories Act, 1996 and the rules framed thereunder, if any."
- e) In Article 46 after the words '___ as the Board may think fit.' to add the words 'In the case of transfer or transmission of shares or other marketable securities where the Company has not issued any certificates and where such shares or securities are being held in a electronic and fungible form in a Depository, the provisions of the Depositories Act, 1996 shall apply."
- To consider and if thought fit, to pass, with or without modifications, the following resolution as a Special Resolution :





"RESOLVED THAT in partial modification of the Resolution passed earlier by the members at the Ninth Annual General Meeting of the Company held on August 12, 1996 and subject to the provisions of Section 198, 269, 309, 310, 311 and other applicable provisions, if any, of the Companies Act, 1956 and also subject to such other consents, permissions and sanctions as may be required from the appropriate authorities, the Company hereby accords its approval to the increase in remuneration payable to Non-Wholetime Directors of the company, including directors rendering services in professional capacity, from 1% to 3% of the netprofits of the Company, computed in accordance with the provisions of Section 198, 349 and 350 of the Act, to be paid and distributed to the Directors of the Company or some/any of them (other than the Managing Director(s)/ Whole-time Director(s)) in such amounts or proportion and in such manner and in all respects as may be decided and directed by the Board of Directors (in addition to the fees payable to such Directors for each meeting of the Board or a Committee of the Board attended by them)."

 To consider and if thought fit, to pass, with or without modifications, the following resolution as a Special Resolution:

"RESOLVED THAT in accordance with the provisions of Section 81(1A) and other applicable provisions, if any, of the Companies Act, 1956 and the Guidelines issued by Securities and Exchange Board of India and pursuant to the Articles of Association of the Company, and subject to the approval of the appropriate authorities, if any, as may be necessary and subject to such conditions/modifications, if any, as may be prescribed in granting such approvals which may be agreed to by the Board of Directors, the Company hereby accords its approval to the offer for subscription/issue for cash, at a price permissible as per the Guidelines issued by appropriate authorities from time to time in this behalf, equity shares not exceeding 5%, or such other limit as may be permitted by appropriate authorities from time to time in this behalf, of the paid-up capital of the Company in any one year to a Trust created to hold such equity shares under the Employees Stock Option Scheme on behalf of and for the benefit of the employees of the Company, including any Director holding a salaried office or employment in the Company and to distribute such shares on an appropriate basis to such employees of the Company as may be decided."

"RESOLVED FURTHER THAT such shares shall rank pari passu in all respects with the existing fully paid up equity shares of the Company, save and except that these equity shares shall be entitled to any dividend declared, if any, on prorata basis in respect of the financial year in which these are alloted from the date of allotment and in proportion to the face value paid up thereon."

"RESOLVED FURTHER THAT the Board of Directors of the Company be and is hereby authorised to make interest-free loans, to give any guarantee or provide any security for an amount not exceeding amount required for the issue of 5%, or such other limit as may be permitted by appropriate authorities from time to time in this behalf, of the paid-up capital of the Company to the Trust as aforesaid. The Board of Directors of the Company is authorised to determine the terms and conditions of such loans, guarantee or security and to decide all or any other matters arising out of or incidental thereto."

"RESOLVED FURTHER THAT for the purpose of giving effect to above resolution, the Board of Directors be and is hereby authorised on behalf of the Company to do all such acts, deeds, matters and things as it may deem fit or necessary or desirable for such purpose with power on behalf of the Company to settle any questions, difficulties or doubts that may arise in this regard as it may in its absolute discretion deem fit."

 To consider and if thought fit, to pass, with or without modifications, the following resolution as an Ordinary Resolution :
