Your Directors have pleasure in presenting the 23nd Annual Report, together with Audited Statement of Accounts for the year ended 31st March, 2006.

3) WORKING RESULTS :

Due to growing competition alongwith overall recession in the industry, the turnover for the year amounted to Rs. Nil compared to Rs. Nil in the previous year. The Company earned by way of Commission Rs. 4,24,563/- which enabled the Company to earn a net profit of Rs. 1,19,462/- as against a Net Profit of Rs. 67,865/- in the previous year.

4) FIXED DEPOSITS :

The Company has not accepted Deposits from the Share holders or public. There were no unclaimed or unpaid deposits outstanding as on 31st March, 2006.
