




ITC Maurya Sheraton was awarded the ISO 14001 Environmental Management Systems certification, the first for any hotel in India.

The new Super Deluxe 80-room extension at the ITC Maurya Sheraton is expected to open shortly. ►




The ITC Grand Maratha, located near the Sahar Airport in Mumbai, will be ready for commissioning in the last quarter of 2000.









