The Company was incorporated with the name JAYKETAN TEXTILES PRIVATE LIMITED in the year 1968. The Company was converted in Public Limited Company in the year 1993. The turnover of Cotton waste is declining. The Company proposed to diversify in the field other than Cotton waste. Since the Company has further plans to diversify into new fields of E-COMMERCE, it is proposed to change its name to 'INDIA E-COMMERCE LIMITED' or such other name as may be permitted by the Registrar of Companies, and acceptable to the Board of Directors of the Company.
