

FINANCIAL REVIEW

During the year, the Company showed an improved performance both in terms of turnover and profitability. Gross turnover increased by 7.4% from Rs. 4918.08 million in year 2003-04 to Rs 5282.28 million in year 2004-05. Profit after Tax also went up by 12.8% from Rs. 821.94 million in 2003-04 to Rs. 926.85 million in 2004-05.

DIVIDEND

Your Directors are pleased to recommend dividend at an enhanced rate of 20% (Rs. 2 per share) as against 15% (Rs. 1.50 per share) in the last year. The proposed dividend including corporate dividend tax would absorb Rs. 319.8 million.

PERFORMANCE HIGHLIGHTS

CNG BUSINESS:

Your Company further augmented its CNG distribution infrastructure during the year. The total number of CNG stations increased from 120 in March 2004 to 134 in March 2005, which included 59 mother stations, 33 online stations, 38 daughter booster stations (including 2 in Noida) and 4 daughter stations. The compression capacity went up from 16.13 Lakh Kg/day in March 2004 to 16.88 Lakh Kg/day in March 2005. An additional 10 kms (approx) of 4" Dia. steel pipeline was laid and commissioned to convert 9 CNG stations online.

The Company has entered into a formal agreement with Delhi Transport Corporation (DTC), its largest customer for supply of CNG. In continuation of its commitment to give priority to public transport sector, CNG facility was installed at three more DTC depots, making overall 22 depots to have such facility.

The population of vehicles in Delhi, running on CNG, has gone up to more than 94,000 as on March 31, 2005, which includes about 10,480 buses.


PNG BUSINESS:

The Company has extended the piped natural gas distribution infrastructure to the new areas in Delhi, which include Patparganj, Mayur Vihar Phase-I, Andrews Ganj Extension, Som Vihar, Mayfair Garden and Rohini (Sectors 9, 13 & 14).

During 2005-06, the Company plans to extend its PNG distribution network to Kidwai Nagar, Andrews Ganj, Laxmi Bai Nagar, Netaji Nagar, R.K.Puram (Sectors 8, 12 & 13), Chanakya Puri, Asiad Village, HUDCO, Kali Bari/BKS Marg, Lodhi Colony, Vasundhara Enclave, Mayur Vihar Phase-II, Rohini (Sector 15), Vikas Puri, Paschim Vihar and Pitam Pura.

The Company continued its drive to get prestigious customers for PNG supply with the addition of Akshardham Temple,

Gurudwara Banglasahib, Holy Family Hospital, Escorts Hospital, Hotel Claridges, Hotel Samrat, Haldiram, Scope Complex, Ambassador's Sky Chef, Taj Air Caterers and American Embassy School.

As on March 31, 2005, the Company has provided PNG connections to 25,103 domestic, 140 small commercial and 34 large commercial customers.

FUTURE OUTLOOK

NCT OF DELHI

Your Company has drawn out plans to consolidate its presence in the city of Delhi by investing Rs. 947 million during the financial year 2005-06 for CNG expansion.

Your Company has also planned a capital expenditure of Rs. 442 million for PNG expansion in Delhi during the financial year 2005-06 to provide additional PNG connections to over 30,000 domestic households, 75 small commercial and 16 large commercial customers.

EXPANSION IN NATIONAL CAPITAL REGION (NCR)

The Company commissioned two CNG facilities in Noida (U.P.) in December, 2004, its first step outside the NCT of Delhi. With this the Company has embarked upon expansion of its gas distribution network in the NCR cities. The Company

has secured gas allocation of 0.7 MMSCMD from Ministry of Petroleum & Natural Gas for expanding its gas distribution network in Noida including Greater Noida, Gurgaon and Faridabad. In the first phase the Company plans to create its gas network in these cities with an investment of Rs. 166.38 crores spread over a period of three years. Your Company is actively pursuing with the local administration of these cities / State Governments of UP and Haryana for the necessary statutory permissions to set its plan rolling. As soon as the decks are cleared, your Company is geared up to repeat the success story of NCT of Delhi in these NCR cities also.

Shri S.N.Sahai, nominee of Government of NCT of Delhi was appointed as an Additional Director in place of Shri Rajeev Talwar w.e.f. March 19, 2005.

HUMAN RESOURCES

During the year your Company enjoyed cordial human relations amongst all its employees. The Company engaged a reputed HR Consultant to carry out a comprehensive human resource study and suggest an appropriate organisation structure. performance management system, promotion policy and compensation structure for its employees. The Consultant has submitted its initial report which is under review of the Management.

There was no employee in the Company drawing remuneration more than the limits prescribed under section

217 (2A) of the Companies Act, 1956 read with the Companies (Particulars of Employees) Rules, 1975.

IT INITIATIVES

The Company is in the process of implementing SAP solution for automating and formalizing its business process & functioning. The Company also aims to collate valuable customer information database by introducing Customer Relationship Management (CRM). In order to optimize cost the Company plans to have Supply Chain Management after implementing SAP, which would track the product movement and costs associated thereto.

The Company is also in the process of implementing Geographic Information System (GIS) to electronically map its pipeline network. This would facilitate the network documentation processes, optimize network design, improve customer service, ensure efficiencies into the workflow process and address many other vital business needs.

FIRE & SAFETY

Your Company took certain new initiatives for safety during the year. The Company developed its first Fire Training Demo site at Rohini Fire Station. It has developed Dry Chemical Powder based fire-fighting system for buses being refilled at

the CNG Mother Stations.

During the financial year 2005-06 the Company plans to carry out Hazard & Operability (HAZOP) Study & Risk Assessment and develop a Disaster Management Plan. The Company also aims at forming a Safety Management System.

SOCIAL RESPONSIBILITY

Your Company is contributing to the cause of reducing the vehicular pollution by providing eco-friendly fuel to the public transport system of the National Capital Territory of Delhi. The results are visible in the form of reduced level of air pollution in the NCT of Delhi. The Company has already set the ball rolling to repeat the same success story in adjoining cities of Noida including Greater Noida, Gurgaon and Faridabad.

Your Company is also working towards redefining customer standards by providing the uninterrupted, economic and environment friendly fuel to its customers.



ANNEXURE TO DIRECTORS' REPORT

A. CONSERVATION OF ENERGY

Some of the energy conservation schemes being implemented by the Company are as follows:

- Modified the starters of 06 Nos. of the Gas Engines of Galileo-make compressor packages. These starters that earlier operated on natural gas have now been modified to operate on compressed air. This has saved substantial amount of Natural Gas used for starting of these compressor packages.
- To reduce gas venting during starting and stopping of the compressors, PLC logic modifications of 36 Nos. of Dresser-Rand packages have been carried out. By carrying out the modifications in the control logic, wastage of natural gas due to popping of safety relief valves has been eliminated.
