



6. The Annual general meeting for the financial year ended on **31<sup>st</sup> March 2001** was held on **29<sup>th</sup> September 2001**, after giving due notice to the members of the Company and the resolutions passed thereat were duly recorded in Minutes Book maintained for the purpose.
