Sub : Depository System - Trading and holding of shares in electronic form -

We are happy to inform that your Company has joined National Securities Depository Limited (NSDL) to enable you to hold and trade our company's shares in electronic form (Depository System). Your Company is the third Company from Tamil Nadu to join NSDL and the first Company from Tamil Nadu to pay one time custodial charges to NSDL. By this, NSDL will not collect any of their charges from the Depository Participants/Shareholders of K G Denim Limited. This will considerably benefit investors/shareholders of KGDL to hold our company's shares in electronic form.

PREAMBLE :

Depository System is long prevalent in many advanced countries and has been playing a significant role in stock markets around the world. The system is time tested and reliable. In India, the first Depository has been set up by NSDL which is jointly promoted by IDBI, UTI and NSE in accordance with the regulations framed by SEBI.

As the concept of Depository System is new to the investors/companies in India, we share, inter-alia, certain basic informations regarding the Depository System to assist you in deciding to opt for holding your securities in electronic form.

Depository System :

The present scrip-based system involves enormous paper work in the form of certificates and transfer deeds. Also, the process beginning from purchase of shares till getting them transferred is very complex, time consuming and riddled with variety of problems such as bad deliveries, fake certificates, loss in transit, mutilation of certificates, etc., All these hardships are alleviated under the Depository System. The Depository System essentially aims at eliminating the voluminous and cumbersome paper work and offers scope for "Paperless Trading". Under the Depository System, you keep your securities with NSDL in the same way as you keep your money in a bank.

The depository is an organisation where the securities of an investor are held in electronic form. All rights will lie with the investor and the Depository acts only as a custodian. The physical certificates are destroyed and the particulars of holding are transmitted into electronic form and further transactions and transfers are done electronically without involving any exchange of papers, i.e., certificates and transfer deeds. It also offers option for converting the shares from electronic to paper form.

The Benefits under Depository System :

1. No stamp duty is payable for transfer.
2. No courier/postal charges are involved.
3. Eliminates enormous paper work.
4. Transfers/payments are effected on the very same day of payout.
5. Overcomes the problems of bad deliveries, fake certificates, mutilation of certificates, etc.,

6. Eliminates risks such as loss in transit, theft, etc.,
7. Facilitates freezing/locking of investors accounts which enables you to make your account non-operational, if you so desire, for instance if you are in abroad.
8. Facilitates pledge/hypothecation/lending of securities.
9. No fear and tension when the certificates are sent for transfer till they are received back.
10. Reduces transaction charges.

Depository is an organisation which holds and transfers securities on behalf of the investor in electronic form.

How to open depository account and trade :

You can open an account with a depository participant of NSDL (list of participants attached). Deposit the share certificates alongwith the Dematerialisation Request Form with the Depository Participant. Your account will be credited within 15 days and a Pass Book like statement will be issued to you indicating your holdings. If you wish to sell/buy electronic shares, inform about your depository account to the brokers who will guide you.
