**ITEM NO. 4:**

Mrs. Gangaben Raman Pagi, aged about 51 years, has joined the Board as Non-executive Woman Independent Director with effect from June 30, 2015. Mrs. Gangaben Raman Pagi holds directorship in i other Companies – Shlok Mercantile Private Limited.

The Company has received from Mrs. Gangaben Raman Pagi:

- (i) Consent in writing to act as Woman Independent Director in Form DIR-2 pursuant to Rule 8 of the Companies (Appointment & Qualification of Directors) Rules 2014.
- (ii) Intimation in Form DIR-8 in terms of Companies (Appointment & Qualification of Directors) Rules, 2014 to the effect that she is not disqualified under sub-section (2) of Section 164 of the Companies Act, 2013 and
- (iii) A declaration to the effect that she meets the criteria of independence as provided in sub-section (6) of Section 149 of the Companies Act, 2013.

The Board of Directors of your Company, after reviewing the provisions of the Act, are of the opinion that Mrs. Gangaben Raman Pagi fulfills the conditions specified in the Act and the Rules made thereunder and also the provisions as laid down in Listing Agreement to be eligible to be appointed as Woman Independent Director pursuant to the provisions of section 149 of the Act. The Board considers that her continued association would be of immense benefit to the Company and it is desirable to continue to avail services of Mrs. Gangaben Raman Pagi as an Independent Director. Accordingly, the Board recommends the resolution in relation to appointment of Mrs. Gangaben Raman Pagi as Woman Independent Director of the Company for a term of 5 years pursuant to provisions of section 149 read with Schedule IV of the Act for the approval by the shareholders of the Company. In terms of provisions of section 149(13) of the Act, Mrs. Gangaben Raman Pagi shall not be liable to retire by rotation.

During the year under review, the Company has suffered loss from operation of ₹ 6.75 Lacs in comparison with ₹ 4.34 Lacs during the previous year.
