Managing the Merger

KPIT INFOSYSTEMS LIMITED was promoted in 1990 by professionals from the field of finance, information technology and consulting to provide global quality IT services to their clients.

CUMMINS INFOTECH LIMITED was promoted in 1999 by Cummins, the world's leading independent engine manufacturer, to provide information technology services to Cummins.

By 2002, KPIT grew to a team of over 300 professionals rendering IT Services all over the world to clients from various industries including manufacturing.

Over two and half years, CIT built a team of 60 professionals having expertise in the areas of lotus notes and e-business.

KPIT was looking for a partner in the manufacturing vertical who could provide domain expertise, better predictability through committed revenues and an opportunity to create a centre of excellence by integrating the partner's manufacturing expertise with KPIT's software capabilities.

Cummins was looking for a partner with a broad range of skills, proven software development processes, ability to execute large number of projects and to scale up quickly - a partner who would quickly take up the growing IT needs of Cummins globally and bring in significant cost savings.

KPIT had proven quality systems. KPIT had an ISO 9001:1994 certification from 1997 and was certified to be CMM Level 4, which put it amongst the top 120 companies in the world in terms of process maturity in software life-cycle management.

KPIT & Cummins, sharing similar philosophy with complimentary needs decided to come together to form a partnership with a view to create a global IT consulting company of first choice. This partnership was formed with effect from 1.1.2002 by the merger of CUMMINS INFOTECH LIMITED into KPIT INFOSYSTEMS LIMITED to form KPIT Cummins.





Over the last 18 months, since the merger in January 2002, KPIT Cummins has grown from strength to strength.

The number of software professionals serving Cummins needs has increased five fold. The service spectrum to Cummins increased from lotus notes and e-business to oracle applications, embedded software, tools, definition management and engineering tools. Apart from providing software development services, we also provide services in IT strategies helping Cummins define its future IT direction like defining 'Preferred IT Environment', leveraging ERP deployments for business benefits and IT roadmap aligning business roadmap. We also work with Cummins teams in 'Product Preceding Technology' projects. KPIT Cummins has provided the highest degree of outsourcing to Cummins amongst all its vendors. It has also been rated as the best vendor.

Consequent to all the above, the level of work done by KPIT Cummins for Cummins has grown five and a half times over the last six quarters. The share prices of KPIT Cummins over the last 18 months quadruplicated.

Our new logo embodies the spirit of our global vision. Its meaning works at many levels.


