

**Ordinary Business:**

1. To receive, consider and adopt the Audited Balance Sheet as at 31st March, 2001, Profit & Loss Account for the year ended on that date and the Reports of the Board of Directors and Auditors thereon.
2. To appoint a Director in place of Mr. B. R. Maheshwari who retires by rotation and being eligible offers himself for re-appointment.
3. To appoint a Director in place of Mr. Atul Jain who retires by rotation and being eligible offers himself for re-appointment.
4. To appoint a Director in place of Mr. S. V. Shanbhag who retires by rotation and being eligible offers himself for re-appointment.

### ANNEXURE TO THE NOTICE

Explanatory Statement under Section 173(2) of the Companies Act, 1956.

#### Item No. 6 :

The Board of Directors at its meeting held on 30th March, 2001 considered and approved subject to the approval of Members at the Seventeenth Annual General Meeting, the re-appointment of Mr. Tarun Jain as a Whole-time Director for a further term of Five Years with effect from 1st April, 2001.

His re-appointment is in accordance with the provisions of Schedule XIII to the Companies Act, 1956.

The main terms and conditions of the re-appointment as specified in the draft agreement as to the remuneration payable to him are as follows:

Remuneration:-

#### A. Salary & Perquisites:

The total value of the above mentioned or any other perquisites payable shall not exceed annual salary.

#### B. Payment of the following perquisites will not be included in the computation of the ceiling on remuneration:

- (i) Provident Fund/Superannuation Fund:  
Company's contribution to Provident Fund or Superannuation Fund or Annuity Fund to the extent these either singly or put together are not taxable under the Income-tax Act, 1961.
- (ii) Gratuity:  
One-half month's salary for each completed year of service.
- (iii) Leave & Leave Encashment:  
Privilege leave of one month for every 11 months of service. Encashment of accumulated leave at the end of the tenure.

#### C. Minimum Remuneration:

The above remuneration of (i) and (iii) (i.e. Salary & Perquisites) will be paid as Minimum Remuneration in case of loss or inadequacy of profits for any financial year during the term of his re-appointment.

#### D. The Whole-time Director will also be entitled to:-

- (a) A provision of car with driver (or reimbursement of driver's salary) for the use of Company's business.
- (b) Free telephone facility at residence.
- (c) Reimbursement of all reasonable expenses including entertainment expenses incurred in connection with the business of the Company.

He shall not be paid any sitting fees for attending the meetings of the Board of Directors or Committees thereof.

No other Director other than Mr. Tarun Jain and Mr. Jaipal Jain is interested or concerned in the resolution.

The above should be treated as an abstract as required under Section 302 of the Companies Act, 1956.

Your Directors hereby present their Seventeenth Annual Report on the operations of the Company along with the Audited Financial Statements of Account for the year ended 31st March, 2001.

**DIVIDEND:**

Due to inadequacy of profits during the year and with a view to conserve and plough back the resources of the Company, the Board of Directors has decided not to recommend any dividend for Financial Year 2000-01.

**REVIEW OF OPERATIONS:**

The Company achieved the turnover of Rs. 126.67 Lacs during the year as compared to Rs. 285.10 Lacs during the previous year. The Profit before and after tax increased from Rs. 5.94 Lacs and Rs. 5.94 lacs respectively of the previous year to Rs. 13.03 Lacs and Rs. 11.97 Lacs respectively of the year under review.

**FUTURE PROSPECTS:**

During the year under review, there were signs of improvement in the real estate market, but there being lack of stock of completed/finished units for sale, the Company could not show better results than projections made for the year. Lower interest rates and unprecedented scams in the

Stock Markets have left people with no alternative but to look for other sources of investment of their moneys. This can once again bring about boom in prices of real estate market.

In such improving circumstances for real estate market, your Directors have thought it fit to commence construction work at the Company's one more prestigious project at Andheri (East), Mumbai in a near future. This project consists of commercial and residential Buildings. The project being located at the central place of the city of Mumbai, your Directors are hopeful that it will strengthen the working of the Company in future.

**SUBSIDIARY COMPANY:**

The Annual Statements of Account of Subsidiary Company, viz., M/s. Doongursee Diamond Tools Ltd., for the year ended 31st March, 2001 are attached herewith. The Statement of Company's interest as a Holding Company, in the Subsidiary as specified in Sub-section 3 of Section 212 of the Companies Act, 1956 is annexed hereto.

As on 31st March, 2001, the Company was not holding any Fixed Deposits and accordingly, there were no outstanding Deposits repayable on that date.

We have audited the attached Balance Sheet of KAMANWALA INDUSTRIES LIMITED as at 31st March, 2001 and also the Profit and Loss Account of the Company for the year ended on that date annexed thereto.

We report as follows:

1. As required by the Manufacturing and Other Companies (Auditor's Report) Order, 1988 issued by the Company Law Board in terms of Section 227 (4A) of the Companies Act, 1956, we give in the Annexure a statement on the matters specified in paragraphs 4 and 5 of the said Order to the extent applicable to the Company.
  - (a) We have obtained all the information and explanations which to the best of our knowledge and belief were necessary for the purposes of our audit;
  - (b) In our opinion, proper books of account as required by Law have been kept by the Company so far as appears from our examination of the books;

3. Attention is invited to Notes to the Accounts in Schedule 18 with regards to the following:
  - (a) **Note 1(f) — regarding non-provision of accruing future liability for gratuity and other retirement benefits which is not actuarially determined.**
