DIRECTORS' REPORT:

To the Members of the Company,

Your Directors hereby present their Ninth Annual Report on the business and the operations of your Company and the audited Statement of Accounts for the year ended 30th September, 1999.

SHARE CAPITAL:

The Authorised Share Capital and the Paid-up Share Capital of the Company remained at Rs. 10.00 Crores and Rs. 6.50 Crores respectively.

PRODUCTION:

During the year under review, the production of Spun Silk Yarn was 2,193.72 Kgs.

SALES:

The Sales turnover during the current year was Rs. 109.04 Lakhs.

The quantity of Spun Silk Yarn sold during the year was 8.686.92 Kgs.

PERFORMANCE OF THE COMPANY:

Your Directors report that during the year 1998-99, the recession in spun silk market continued especially on account of continued export of silk waste, thereby escalating the financial cost. Thus the Company has incurred a Loss of Rs. 728.04 Lakhs and consequently the Company has become a Sick Industrial Company within the meaning of Section 3 (1) (o) of the Sick Industrial Companies (Special Provisions) Act, 1985 (SICA), as the accumulated losses exceed the entire networth as per the Audited Accounts for the year ended 30th September, 1999.

TECHNOLOGY:

By updating the technology, the Company anticipates a further higher rate of production during the year 1999-2000.

BOARD OF DIRECTORS:

Dr. G. Rangaswami and Sri. J. Mohammed Azam Jan, will be retiring at the ensuing Annual General Meeting by rotation and being eligible, offer themselves for reappointment.

ICICI Limited withdrew Sri. E.V. Hariharan, as its Nominee Director during the year.

AUDITORS:

M/s. S. Janardhan & Associates, Chartered Accountants, Bangalore, the Auditors of the Company retire at the conclusion of this Annual General Meeting and being eligible, are recommended for re-appointment.
