Your directors have pleasure in presenting the thirty first annual report together with the audited accounts for the year ended 31st March 2009.

OPERATIONS

During the year under review, the Gross income of the Company reduced to Rs.4.04 lakhs as against Rs.28.86 lakhs during the previous year with a fall in the dividend and interest income from its investments. The Company made a loss of Rs.1.07 lakhs as against a loss of Rs.9.24 lakhs during the previous year.

At the ensuing annual general meeting, Mr. R. Surendran, Director retires by rotation and being eligible offers himself for re-appointment.

AUDITORS

M/s. Shanker Giri and Prabhakar, Chartered Accountants, Chennai retire from the office of auditors and are eligible for re-appointment.

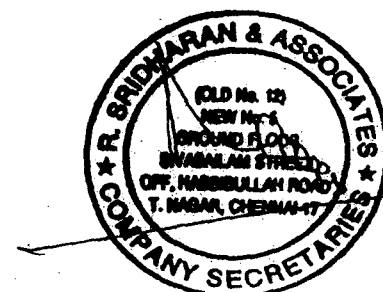
