Your Directors have pleasure in presenting this Thirteenth Annual Report of your Company together with the Audited Statement of Accounts of the Company for the Year ended 31st March, 1997.

OPERATIONS

During the year under reivew, the Company has achieved a sales turnover of Rs. 831.46 Lacs with an increase of 100.7% over the previous year. The existing operations of Mansa Plant for manufacturing of PVC Pipes has generated the profit after Interest and depreciation of Rs. 48.97 lacs as Compared to Rs 10.66 lacs of the previous year.

During the year under reivew the Company has successfully implemented the diverification project for manufacturing of PVC Fittings at Mansa, Gujarat. The commercial production commenced in August 1996. The Company has obtained the disbursement of Term Loan of Rs. 187.50 lacs from G.I.I.C. and Rs. 112. 50 Lacs from G.S.F.C. to part finance the said project.

The new plant, for manufacture of PVC Fittings, was operational for the part of the year therefore, it could contribute only marginally to the turnover of the company. However, depreciation charged for the new plant was Rs. 32.25 lacs and interest charges on the Term loan taken for the new plant was Rs. 30.00 lacks. Thus, the overall profitability of the Company was adverly affected.

DEPOSITS

During the year, Your Company has accepted deposit within the meaning of Section 58A of the Companies Act, 1956 and the rules made thereunder. The total Deposit outstandinh as on 31 - 03 - 1997 is Rs. 35.10 Lacs.
