Notice

Notice is hereby given that the sixty third Annual General Meeting of BOC India Limited will be held at Kala Mandir, 48 Shakespeare Sarani, Calcutta 700 017 on Thursday, 28 January 1999 at 10.30 a.m. to transact the following business:

- 1 To receive and consider the Profit & Loss Account for the year ended 30 September 1998, the Balance Sheet as at that date and the Reports of the Directors and Auditors thereon.
- 2. To appoint Directors in place of those retiring.
- 3. To appoint Auditors and fix their remuneration and, in this connection, to consider and, if thought fit, to pass with or without modification, the following resolution which will be proposed as a Special Resolution:

"That Messrs Price Waterhouse, Chartered Accountants, be and are hereby reappointed as the Auditors of the Company from the conclusion of this meeting until the conclusion of the next Annual General Meeting at a remuneration and on terms as may be determined by the Board of Directors of the Company plus out-of-pocket expenses."

As Special Business

To consider and, if thought fit, to pass with or without modification, the following resolution:

- 4. As an Ordinary Resolution
 - "(1) That consent of the Company be and is hereby accorded in terms of Clause (a) of Sub-section (1) of Section 293 and other applicable provisions, if any, of the Companies Act, 1956, to the mortgaging and/or charging by the Board of Directors of the Company ("the Board") of all or any of the immovable and movable properties of the Company present and future pertaining to the whole or substantially the whole of the Company's

undertaking of the 1290 tonnes-per-day Air Separation Unit Plant at Jamshedpur and the Company's tonnage Plant undertaking at Taloja to or in favour of all or any one of The Industrial Credit and Investment Corporation of India Limited now known as ICICI Limited (ICICI), Punjab National Bank (PNB) and ANZ Grindlays Bank (ANZ) to secure the Rupee Term Loan not exceeding Rs 1400 million lent and advanced by ICICI, PNB and ANZ to the Company together with interest at the respective agreed rates, interest tax, additional interest, liquidated damages, premia on prepayment or on redemption, commitment fees, costs, charges, expenses and other monies payable by the Company to ICICI, PNB and ANZ in terms of the Loan Agreements/Deeds of Hypothecation entered into by the Company in respect of the said term loans.

- "(2) That the Board be and is hereby authorised to agree with all or any of the said ICICI, PNB and ANZ in terms of the Loan Agreements/Deeds of Hypothecation/Letters of Sanction to reserve a right to take over the management of the business and undertaking of the Company in certain events.
- "(3) That the Board be and is hereby authorised to finalise with the said ICICI, PNB and ANZ the documents for creating the aforesaid mortgage and/or charge and to do all such acts and things as may be necessary for giving effect to this resolution."
- 5. As a Special Resolution

"That the Articles of Association of the Company be altered as follows:-

- (a) by incorporating the following definitions in the definitions provided in the existing Article 1:
 - "Beneficial Owner" means a person whose name is recorded as such with a depository.

"Depositories Act" means the Depositories Act, 1996 and shall include any statutory modification(s) or re-enactment(s) thereof for the time being in force.

"Depository" means a Depository as defined under Clause (e) of Sub-section (1) of Section 2 of the Depositories Act, 1996.

- (b) by replacing the word "four" with the word "three" in Article 13.
- (c) by inserting the following Article 16A after the existing Article 16:

"16A. (i) Upon receipt of certificate of securities on surrender by a person who has entered into an agreement with the depository, the Company shall cancel such certificate and substitute in its records the name of depository as the registered owner in respect of the said securities and shall also inform the depository accordingly.

- (ii) If a beneficial owner opts out of the depository in respect of any security of the Company and the Company receives due intimation thereof from the depository, the Company shall on fulfilment of such conditions and on payment of such fees as may be prescribed or determined by the Board, issue certificate of the said securities to the beneficial owner or the transferee, as the case may be."
- (d) by inserting the words "or nominee of a member" after the words "or minor member or any person" in the existing Article 46.
- (e) by inserting the following Article 47A after the existing Article 47:

"47A. Nothing contained in Articles 37 to 47 shall apply to transfer or transmission of shares effected by the transferor and the transferee both of whom are beneficial owners."

(f) by inserting the words "as the beneficial owner" after the words "either to be registered himself" in the proviso to the existing Article 48.

- (g) by inserting the following Clause (c) after the existing Clause (b) in the existing Article 77:
 - "(c) a depository, as a registered owner in the records of the Company in respect of its securities, shall not have any voting rights or any other rights in respect of the securities registered in the name of the depository except for the purposes of effecting transfer of ownership of such securities on behalf of beneficial owner(s)."
- (h) by inserting the words "or beneficial owner" after the words "registered holder" wherever they appear in the existing Article 144.
- (i) by inserting the following proviso after the existing Clause 4 of Article 172:

"Provided that the Register and Index of the beneficial owners maintained by the depository under Section 11 of the Depositories Act shall be deemed to be the Register and Index of Members maintained in compliance with Sections 150 and 151 of the Act."

by inserting the following proviso after the existing Clause 5 of Article 172:

"Provided that the Register and Index of the beneficial owners maintained by the depository under Section 11 of the Depositories Act shall be deemed to be the Register and Index of Debentureholders maintained in compliance with Section 152 of the Act."

The Register of Members of the Company will remain closed from 12 January 1999 to 28 January 1999 both days inclusive.

- 1 A member entitled to attend and vote at the meeting is entitled to appoint a proxy to attend and vote instead of himself and such proxy need not be a member of the Company. Proxies, in order to be effective, must be received by the Company not less than 48 hours before the meeting.
- 2 Dividends which remained unpaid or unclaimed upto 44th Dividend declared at the 60th Annual General Meeting held on 1 February 1996 have been transferred to the General Revenue Account of the Central Government. Notices pursuant to Rule 4A of the Companies Unpaid Dividend (Transfer to General Revenue Account of the Central Government) Rules, 1978 have been sent to all shareholders concerned.

Annexure to the Notice convening the 63rd Annual General Meeting to be held on Thursday, 28 January 1999

As the business specified in item nos 4 and 5 of the Notice of even date to which this statement is annexed is an item of special business to be transacted at the sixty third Annual General Meeting of the Company, the following facts are set out in compliance with the provisions of Section 173 of the Companies Act, 1956 ('the Act').

Item No 4

The Company has availed of term loans of Rs 700 million from The Industrial Credit and Investment Corporation of India Limited now known as ICICI Limited (ICICI), Rs 400 million from Punjab National Bank (PNB) and Rs 300 million from ANZ Grindlays Bank (ANZ) aggregating Rs 1400 million in connection with the setting up of the 1290 tonnes-per-day (tpd) Oxygen capacity Air Separation Unit Plant at Jamshedpur, Bihar, to meet the oxygen, nitrogen and argon requirements of The Tata Iron and Steel Company Limited (TISCO) as well as to meet the Company's requirements of gases for the merchant market in Eastern India at a total cost of about Rs 2000 million. The aforesaid financial assistance have to be secured by a first mortgage of all immovable properties of the Company present and future pertaining to the 1290 tpd Air Separation Unit Plant at Jamshedpur and the tonnage Plant at Taloja.

Section 293(1)(a) of the Act provides, inter alia, that the Board of Directors of a public company shall not without the consent of such company in general meeting sell, lease or otherwise dispose of the whole or substantially the whole, of the undertaking of the company, or where the company owns more than one undertaking, of the whole, or substantially the whole of any such undertaking.

Since the mortgaging/charging by the Company of its immovable and movable properties as aforesaid in favour of ICICI, PNB and ANZ may be deemed to be disposal of the Company's undertakings in respect of the 1290 tpd Air Separation Unit at Jamshedpur and tonnage Plant at Taloja, it is necessary to seek the consent of the members under Section 293(1)(a) of the Act for the said mortgage/charge, credited and/or to be credited in favour of ICICI, PNB and ANZ.

A copy of each of the Agreements executed by the Company with ICICI, PNB and ANZ will be available for inspection of the members at the Registered Office of the Company on any working day during the usual business hours of the Company and will also be available at the meeting.

The Board recommends that the resolution be passed. None of the Directors of the Company is interested or concerned in the resolution.

Item No 5

A. Clauses (a), (c), (e), (f), (g), (h), (i) and (j)

The Depositories Act, 1996 ("Depositories Act") was enacted to give a boost to the securities market in India and has paved the way for electronic scripless trading in dematerialised securities in the stock exchanges. Certain provisions of the Companies Act, 1956 ("the Act"), the Securities Contracts (Regulation) Act, 1956 and the Indian Stamp Act, 1899 have also been amended in order to fulfil the objects of the Depositories Act.

Under the laws relating to the depository system, the securities issued by a company are permitted to be held with a depository in dematerialised form at the option of either the Company or an investor, subject however to the appropriate rules and regulations prescribed by the Securities and Exchange Board of India ("SEBI").

If and when the securities issued by the Company are placed under the depository system, the Company will be under obligation to comply with the provisions of the Depositories Act and the other relevant rules and regulations made by SEBI. It is therefore considered that for administrative convenience the Articles of Association of the Company should be altered suitably so as to bring them in conformity with the provisions of the Depositories Act and those of the Act as have been amended by the former.

B. Clause (b)

Article 13 provides that not more than four persons shall be registered jointholders of any share. It is proposed to reduce the number to three in

compliance with the changes in the Act and the Share Transfer form.

C. Clause (d)

The Companies (Amendment) Ordinance, 1998 ("Ordinance") promulgated by the President of India which has come into effect from 31 October 1998 has inserted Sections 109A and 109B to the Act providing the facility of nomination by a member in the event of his death. The Articles of Association is proposed to be amended to include nomination facilities in the Articles in terms of Sections 109A and 109B of the Act.

A copy of the Articles of Association of the Company with the proposed alterations will be available for inspection by the members of the Company at its Registered Office during usual business hours on any working day upto the date preceding the date of the Annual General Meeting.

None of the Directors of the Company, other than Mr J N Sapru and Mr S S Prasad who are shareholders of the Company, are interested or concerned in the resolution.

The Board recommends that the resolution be passed.
