### **Performance of the Company:**

Splash pursued a business strategy of being a Marketing & Distribution house for diverse variety of Media Products. During the year under review, the company has achieved a turnover of Rs.311.77 Lacs against Rs.296.75 lacs during the year ended on 31.03.05, resulting to growth of 5.06%. Profit after tax also gone up to Rs.1.81 Lacs from Rs.0.99 Lacs for the year ended on 31.03.05. Splash always believed in qualitative work instead of quantitative, this being the initial year of Media operations, the company focused only on result oriented products and accordingly could achieve the results given above. The above policy will give fruitful results in coming years.

### **Dividend**

During the year under review your company has undergone re-structuring and has strategically expanded and diversified into the high margin arena of Media business. Your Directors recommend a 'conserve cash' policy, essentially to meet the re-structuring objectives. Accordingly, your Directors are not in a position to recommend any dividend for the year ended March 31, 2005.

### **Subsidiaries**

The company does not have any subsidiaries as on 31.03.05.

### **Auditors**

M/s ABN & Co., Chartered Accountants, Mumbai, the present Auditors of the company, retire

at the forthcoming Annual General Meeting and being eligible, offer themselves for re-appointment. They have furnished a certificate to the effect that their re-appointment, if made, will be within the limits prescribed under section 224 (1B) of the Companies Act, 1956.
