DIVIDEND

Due to loss, your Directors have decided not to recommend any Dividend for the year under review.

CANCELLATION OF RIGHT ISSUE

The Company had come out with Right Issue of Equity Shares in the month of January, 97. Due to lukewarm response from the shareholders, the Company could not receive application money for atleast 90% of the issued amount. Therefore, entire subscription amount received by the Company have been duly refunded to the applicants.

DIRECTORS

Shri Naishadh I. Parikh and Shri Jagdish G. Dalal, Directors of the Company, retire by rotation from the Board in terms of the provisions of the Companies Act, 1956 and Articles of Association of the Company, but being eligible offer themselves for reappointment.
