Your Directors have pleasure in presenting their Nineteenth Annual Report together with the Audited Balance Sheet as at 31st March, 2003 and the Profit & Loss Account of the Company for the year ended on that date.

#### FINANCIAL RESULTS:

During the year under review, the Company has suffered a net loss of Rs.1,170,800/- to which is added the debit balance—brought over from earlier years of Rs.1,069,865/- resulting into net debit balance of Rs.2,240.665/- which your Directors propose to carry over to next year.
