## **OPERATIONAL REVIEW**

The year under review has seen the worst ever situation so far as construction industry is concerned. The industry is facing pressing situation from all sides. Due to failure to meet some of the minimum construction norms on the part of few builders, the High Court has intervened. This coupled with a massive earthquake of 26th January, 2001 which demolished number of residential complexes in Bhuj area and Ahmedabad and other parts of the Gujarat, the same has given wrong signals to the public about the construction quality of all builders. It has become a dream only to sale out the residences within a few months. In the present days one may go to the extent saying that there is almost no buyers. On the other hand the regulatory authorities have tightened the construction norms and now a days situation has arisen that even after complying with the prescribed norms by a Company like yours, selling a flat / office is a dream task. To regain the public confidence one will have to wait for at least one or two years and till then management is left with no alternate but to wait and watch for a proper situation and till the time come to run the show.
