

### **DIRECTORS' REPORT**

To,

The Mernbers,

Your Directors have pleasure in presenting the Fifth Annual Report together with the Audited Statement of Accounts for the year ended 30th June 1998.

## REVIEW OF PROGRESS OF THE PROJECT & OPERATIONS

The Company is yet to commence manufacturing activity. However your Company engaged in trading activity and made a net profit of Rs 0.67 lakhs after providing for taxation of Rs.0.27 lakhs.

The implementation of the project is now in its final stage of completion with most of the civil works completed and certain imported machineries already received. Trail runs are expected to begin in March 1999 and the Directors are hopeful that commercial production will begin soon thereafter. The delay has been mainly due to increase in civil work and rescheduling of delivery dates by foreign suppliers of machinery. As a result of the delay there has been slippage in the commencement of production and attainment of turnover and operating profit vis-a-vis projections made in the prospectus dated 5th April, 1995.
