The Company has made application to Board for Industrial and Financial Reconstruction (BIFR) for the declaration of company as Sick Industrial Industry. The Hon'ble Board had declared the Company as sick on 14th July, 2011 and appointed IDBI Bank as Operating Agency for the preparation and finalisation of Rehabilitation Scheme. The Scheme is underprocess.

The management of the Company had approached M/s DIL Limited Thane, for financial Assistance against the issue of Company's Equity Shares to be issued at par post capital reduction on a fully diluted basis.
