# OPERATIONS AND PERFORMANCE DURING THE YEAR:

During the period your Company has been successful in fighting the competition and has achieved the turnover of Rs. 24.48 crores and has made a net loss of Rs 1.53 crores, as compared to net loss of Rs.1.18 crores during the previous year. During the period, your Company has written off an amount of Rs. 2.06 crores towards deferred Advertisement expenditure. The performance of the company has improved over the previous year due to refocus on fast moving products, re-structuring of the organization and stringent cost control measures undertaken by the Company.

In view of the carry forward losses, your Directors are unable to recommend any dividend this year.

#### MANAGEMENT DISCUSSION AND ANALYSIS

#### **OVERVIEW**

During the financial year 2003-2004, the Company achieved a sales turnover of Rs. 24.48 Crores as against a sales turn over of Rs.21.61 Crores in the previous year. Profit before depreciation, tax and extraordinary items aggregated Rs. 78.96 lacs during 2003-2004, compared to profit of Rs. 106.55 lacs during 2002-2003. Net Loss after tax stood at Rs. 153.52 lacs compared to Rs.118.81 lacs in the previous year.

#### **BUSINESS ANALYSIS**

#### **Industry Structure and Developments**

The industrial sector in general and the cosmetics industry in particular, is poised for increased growth after a period of depressed market conditions. The likely improvement in consumer demand and strengthening of rural sector is likely to drive the recovery process.

#### **Paramount Cosmetics**

For the year 2003-2004, the Company achieved a turnover of Rs. 24.48 crores as against Rs.21.61 crores during the year ended 31st March 2003 registering an increase of 13.28%. The Company had test marketed its new range in Colour Cosmetics products in 2002-2003 which had received very good response. The Company is in the midst of launching its new product range of Colour Cosmetics on all India level. Though the Company in relation to Western Cosmetics is relatively small compared to other International majors, it has a strong presence in the Southern and Northern market. The Company has strong presence in the Traditional Cosmetics and is the only National Level Company in India.

#### DOMESTIC SCENARIO

With the opening of the Economy, and the exposure to the western culture, the Cosmetics Industries is expected to grow @ 15% p.a. The Company also is gearing up to meet the challenge and take advantage of the increased demand.

#### **Capital Structure**

There was no change in the capital structure of the Company. The issued and paid up share capital of the company as at 31st March 2004 remains same comprising of 4856650 equity shares of Rs.10 each, aggregating to Rs.485.67 lacs

#### Reserves and Surplus

As at 31st March 2004, Reserves and Surplus of the Company, aggregated Rs. 1132.78 lacs as against Rs.1132.78 lacs as on 31st March 2003.

#### **Gross Block**

During the year, the gross block of the Company has increased to Rs.346.40 lacs as against Rs.313.99 lacs as at previous year-end. The net block as at 31st March 2004 was Rs. 104.99 lacs compared to Rs.93.83 lacs as at previous year-end.

#### Investments

Investments of the Company has reduced to Rs.23,500/-as against Rs.10,23,500/- as at previous year end.

#### **Working Capital**

The net working capital of the Company has increased to Rs. 860.09 lacs compared to Rs. 854.75 lacs in the previous year.

#### Revenue

Sales revenue for the year ended 31st March 2004 increased by Rs.287.02 lacs, as compared to the previous year. Other income increased by Rs. 4.41 lacs for the year, as compared to the previous year.

#### **EXPENDITURE**

#### Raw Materials/Packing Material

There is an increase in the Packing Material cost mainly due to increase in the procurement cost during the year.

#### Interest Outflow

The Company was benefited with falling interest rates. This has led to the reduction interest costs for the year ended 31st March 2004.

#### Depreciation

Depreciation for the year ended 31st March 2004 was Rs. 26.09 lacs compared to Rs.26.64 lacs for the previous year.

#### **Net Loss**

The net loss increased to Rs. 153.52 lacs during 2003-2004, compared to Rs.118.81 lacs during the previous year.

#### Dividend

The Board of Directors have not recommended any dividend due to losses.

#### INTERNAL CONTROL SYSTEMS

The Company has set up a separate Internal Audit Department to carry out internal audit within the framework provided by the Board of Directors. The Internal Auditors conduct pre and post transaction audit checks and monthly reviews are carried out to ensure follow up on the observations made. The Audit Committee of the Board of Directors reviews the Internal Audit Reports and the progress in implementation of audit observations. The

Audit Committee also issue directives and/or recommendations for enhancement in scope and coverage of specific areas, wherever felt necessary.

Human resources are the most valuable assets of the Company and the Company has put in place various systems to reward and recognize employee contribution towards the growth of the Company by instituting production linked and performance based incentives for the employees of the Company.
