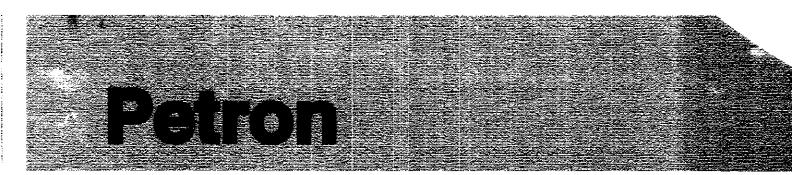
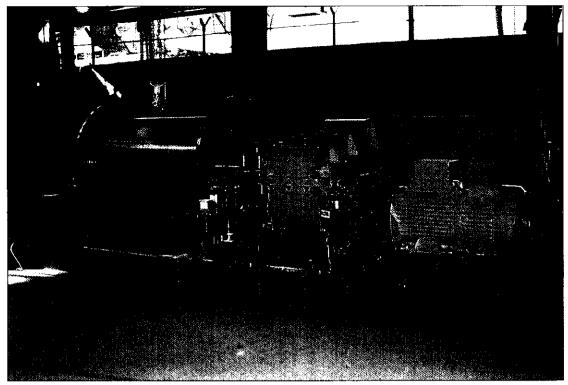

DIVIDEND

For the year under review your Directors have declared on 26.04.2000 an interim dividend of Rs. 1.50 per Equity Share of Rs. 10/- each paid-up absorbing a sum of Rs. 1.25,51,478/- including Corporate Dividend Tax of Rs. 12,43,836/-. Your Directors are now pleased to recommend final dividend of Rs. 0.50 per Equity Share for declaration by the Shareholders at the Twenty-fourth Annual General Meeting. The total dividend for the year will be Rs. 2/- per share, absorbing in the aggregate a sum of Rs. 1.71,49.902/- including Corporate Dividend Tax of Rs. 20,73,060/-.

REVIEW OF OPERATIONS :

During the year under review your Company achieved a turnover of sales and other income of Rs.14,502 Lakhs. The net profit was Rs.363 Lakhs. The downtrend witnessed in sales and net profit was due to the lack of sufficient business opportunities caused by the general sluggishness prevailing in the market.

Construction Division :

During this year the Construction Division successfully completed the execution of contracts in Haldia Petrochemicals Ltd, Haldia; Chambal Fertilizers & Chemicals Ltd, Kota; Indian Oil Corporation Ltd's Mathura, Panipat and Vadodara Units as well as the earlier contracts in Mangalore Refinery & Petrochemicals Ltd, Mangalore. The Division also completed the work on the new orders received for Dharani Cement Ltd's Plant erection work at Reddipalayam, Tamilnadu; Nirma Ltd's LAB plant at Savli, Gujarat; fabrication and erection of piping for Delayed Coker Unit at Reliance Petrochemicals Ltd, Jamnagar and AU-JV plant work for Toyo Engineering India Ltd at Indian Oil Corporation Ltd's Gujarat Refinery Project, Vadodara.

The Division secured new and prestigious orders, among which are :

- Additional Product Pipeline work connecting the Plant to the Jetty at Mangalore Refinery & Petrochemicals Ltd, Mangalore signifying your Company's entry into the cross-country pipelaying work for the first time.
- Equipment and Piping erection work for Toyo Engineering India Ltd, for the Butane and AU III revamping projects at Gujarat Refinery of Indian Oil Corporation Ltd, Vadodara.
- Mechanical works for DAP plant for Uhde India Ltd, for Gujarat State Fertilizer Corporation Ltd at their Sikka and Motikhawdi Units.
- Erection of 210 MW Boilers for Bharat Heavy Electricals Ltd at Suratgarh, Rajasthan.
- Site work for Reactor Regenerator Package and erection of Co-incinerator package for Bharat Heavy Plates Ltd, Vizag and Zeeco, USA respectively at Indian Oil Corporation Ltd, Haldia.

On the Electrical and Instrumentation front, the work in the DHDS Projects at Indian Oil Corporation Ltd's Panipat Refinery, Bharat Petroleum Corporation Ltd's Refinery at Mumbai and Madras Refineries Ltd, Chennai were successfully completed. The Division also secured new orders from Associated Cement Companies Ltd, Thane for their cement plants at Chandrapur and Madukkarai and from Bharat Petroleum Corporation Ltd, Mumbai.



PERFORMANCE - OTHER DIVISIONS :

Rockwool Division :

This Division maintained its good performance this year also, inspite of the generally difficult industrial situation.

The Division successfully completed the Refractory application work at Saint Gobains Float Glass Ltd's plant at Sriperumbudur and Hindustan Sanitary Wares Ltd's (Glass Division) plant at Hyderabad. New orders received by this Division include the refractory and associated mechanical work at M/s Vetrotex Industries India Pvt. Ltd., Hyderabad for their Glass plant and for similar work at Videocon Narmada Glass Industries Ltd, Bharuch, apart from specialized refractory application work for the Reactor / Regenerator Package for Fawley Refinery, U.K. through M/s Larsen & Toubro Ltd., Hazira.

Petron Mechanical Industries Division :

This Division completed the fabrication and erection of gratings for VDU Heater at Indian Oil Corporation Ltd's Mathura Refinery, supply of Gantry Crane to Petron Civil Engineering Ltd., and fabrication of Chimney and Supporting structures for Wartsila NSD India Ltd. for their project at Sutlej.

New orders in hand include the supply and erection of Chimney for Wartsila NSD India Ltd. at their Mukand Steel site, Thane; manufacture and supply of HOT Cranes, Slime Sump Tanks, Gantry Rails and DSL System for Sterlite Industries (I) Ltd., Chinchpada, Silvassa; design, manufacture, supply of 20 MT Electrical Winch and erection Trolley for Ajax Construction Company, Cochin and revamping of Cranes at Saurashtra Cement Ltd, Porbandar.

Petrofab Division :

This Division successfully completed the supply and fabrication of Reformer Convection Modules for Deepak-Fertilizers Ltd at Taloja and SS Plugs for Indian Oil Corporation Ltd's Gujarat Refinery Project at Vadodara as well as manufacturing and supply of APH Modules for ABB Lummus Crest Heat Transfer for the Heaters at Gujarat Refinery Unit of Indian Oil Corporation Ltd, Vadodara. Orders in hand include the supply and fabrication of Air Pre Heater for M/s Zeeco, USA for their Project at Indian Oil Corporation Ltd's Refinery at Haldia.

Petrotech (EPC) Division :

The EPC Division completed the engineering work for the Heaters in Indian Oil Corporation Ltd's Mathura and Vadodara Refineries, the Heater at Nirma Ltd's LAB Plant in Savli and the Heaters at Mangalore Refinery and Petrochemicals Ltd, Mangalore.

The work in hand includes the engineering and drawing preparation for the structural work of FCC and DHDT Plant at Indian Oil Corporation Ltd's Barauni Refinery.

Petron Highway Inn Resort Division :

This Division's performance during the year continued to be profitable in spite of the sluggish market.

OUTLOOK

The unexecuted orders in hand at the end of the year stood at Rs.70 crores. The outlook appears to be encouraging with nearly Rs.90 crores of new orders being finalized in the short span of 4 months since the end of the year under review. With the coming up of the expansion of Indian Oil Corporation Ltd.'s Panipat Refinery, the expansion of Chennai Petroleum Corporation's Chennai Refinery and the starting of work in Indian Oil Corporation Ltd's new Grass Root Refinery at Paradeep as well as the new cement plants of Associated Cement Companies Ltd at Wadi and Gujarat Ambuja Cement Ltd at Chandrapur, there is a marked improvement in business opportunities, which your Company as a leading player in this field, is ideally placed to convert into firm orders.

DELISTING OF THE COMPANY'S SECURITIES ON THE STOCK EXCHANGE, AHMEDABAD

Though the Company had completed all the formalities for the delisting of its securities on the Stock Exchange, Ahmedabad, in accordance with Circular No. SMDRP/CIR-14/98 dated 29th April, 1998 issued by the Securities and Exchange Board of India (SEBI) as well as the formalities and procedures laid down by the Stock Exchange, Ahmedabad, the Stock Exchange deferred to delist the securities. The Company, therefore, approached SEBI for its intervention and necessary directions to the Stock Exchange. SEBI has vide its letter No.SMRDP/ASE/VM/10939/2000 dated 7th July, 2000 advised the Stock Exchange, Ahmedabad not to defer or reject the proposal on the ground taken by it.

Y2K

The Company has completed transition to Y2K without incurring any significant cost.

CONSERVATION OF ENERGY, TECHNOLOGY ABSORPTION AND FOREIGN EXCHANGE EARNINGS AND OUTGO

The Company being engaged in undertaking engineering contracts, executed at different sites in the clients' premises, the disclosure of particulars under Section 217(1)(e) of the Companies Act, 1956, in so far as it relates to the conservation of energy and technology absorption is not applicable. Particulars with regard to foreign exchange earnings and outgo appear under schedule 2.08 (B) W of the Accounts.
