**REPORT ON MANAGEMENT DISCUSSION AND ANALYSIS PURSUANT TO CLAUSE 49 OF THE LISTING AGREEMENT**

The Management of RAVINDRA TRADING AND AGENCIES LIMITED presents its Analysis Report covering performance and outlook of the Company. The report has been prepared in compliance with the requirement of Corporate Governance as laid down in the Listing Agreement. The Management accepts responsibility for the integrity and objectivity of the financial statements. However, investors and readers are cautioned that this discussion contains certain forward looking statements that involve risk and uncertainties.

**a) OVERALL VIEW**

During the year the Company carried out investment activity in shares. The Company is focusing on making investment in shares having long term growth potential. In the changing business environment particularly due to upsurge in economic growth potential and growth in GDP, the investment in shares has become profitable with judicious planning and research based investment in shares.

**b) FINANCIAL PERFORMANCE**

During the year under report the Company made a loss of Rs.22,62,488/- as against loss of Rs.52,846/-. The Company earned income of Rs.5,00,358/- on sale of shares. The loss during the year was due to fall in share prices on the closing stock of the shares held as investments.

**c) INTERNAL CONTROL SYSTEM**

The Company's system and processes are regularly reviewed.

**d) HUMAN RESOURCES**

There are no permanent employees in the Company.

**e) STATEMENT OF CAUTION**
