## NOTICE OF THE ANNUAL GENERAL MEETING

Notice is hereby given that the Thirty Sixth Annual General Meeting of the Members of the Company will be held at NDK Kalyana Mandira, 13th Main, HAL II Stage, 100 Feet Road, Indiranagar, Bangalore 560 008 on Friday, the Twenty Fifth September, 2009 at 3.30 p.m. to transact the following business:

- To consider and adopt the Director's Report and the Audited Profit and Loss Account for the year ended 31st March 2009, the Audited Balance Sheet as at that date and the Auditor's Report thereon.
- To appoint a Director in the place of Sri. K.N.V. Ramani, who retires by rotation and is eligible for reappointment.
- To appoint a Director in the place of Sri. V.K. Swaminathan, who retires by rotation and is eligible for reappointment.
- To appoint a Director in the place of S. Srinivasan who retires by rotation and is eligible for reappointment.
- To appoint M/ś. P.N. Raghavendra Rao & Co., Chartered Accountants, as Auditors of the company for holding office upto the conclusion of the next Annual General Meeting and to fix their remuneration.

#### SPECIAL BUSINESS

To consider and if thought fit, to pass with or without modification, the following resolution as ordinary resolution:

RESOLVED THAT in supersession of all resolutions passed in this regard and pursuant to Section 293 (1) (a) and all other applicable provisions, if any, of the Companies Act 1956, consent of the Company be and is hereby accorded to the Board of Directors of the Company for creation of such charges, mortgages and hypothecations in addition to the existing charges, mortgages and hypothecation by the Company as may be necessary on such of the assets of the Company, both present and future in such manner as the Board may direct for conferring upon and taking possession of the aforesaid assets of the Company in certain events to or in favour of various Banks/ Financial institutions that have granted / agreed to grant financial facilities to the Company upto Rs. 700 Crores for the purpose of the Company's projects and businesses.

To consider and if thought fit, to pass with or without modification, the following resolution as ordinary resolution:

RESOLVED THAT in supersession of all resolution passed in this regard and pursuant to Section 293 (1) (d) and all other applicable provisions, if any, of the Companies Act 1956, consent of the members of the Company be and is hereby accorded to the Board of Directors of the Company to borrow for the business purpose of the Company up to a sum of Rs. 600 Crores (apart from the temporary loans obtained or to be obtained from the Company's bankers in the ordinary course of business), over and above the paid up capital of the Company plus its free reserves, i.e. reserves not set apart for any specific purpose.

 To consider and if thought fit, to pass with or without modification, the following resolution as special resolution.

RESOLVED that consent / approval be and is hereby accorded pursuant to the provisions of Sections 198, 269, 309, 310 and

311 and any other applicable provisions of the Companies Act, 1956 for the appointment of Sri K. Prakash as Executive Director of the Company for a period of five years with effect from 1st July, 2009 on the remuneration recommended by the Remuneration Committee as follows:

- i) SALARY: Rs. 75,000/- per month.
- ii) PERQUISITES: Not included in the ceiling on remuneration.
  - (a) Contribution to Provident Fund/Super Annuation Fund or Annuity Fund to the extent either singly or put together are not taxable under the Income Tax Act.
  - (b) Gratuity at the rate of half a month's salary for each completed year of service.
  - (c) Encashment of leave at the end of the tenure.

## (iii) OTHER PERQUISITES:

The Executive Director shall also be entitled to perquisites such as Company owned or hired furnished accommodation with gas, electricity, furniture, water and furnishing or alternatively monthly house rent allowance, medical reimbursement for self, spouse, dependent children and dependent parents, one month earned leave per year on full pay and perquisites with liberty to accumulate such, casual and sick leave as applicable to the other officers of the company, leave travel concessions and allowances per self, spouse, dependent children and dependent parents including foreign travel, club fees and personal accident insurance.

Subject to the conditions that perquisites shall be restricted to an amount equal to 6 months salary.

The unutilized portion of the perquisites in any financial year may, at the option of the Executive Director be encashed at the end of the financial year or carried over to subsequent year/years to be encashed or availed during the tenure of office of the Executive Director.

The above salary and perquisites may be paid as minimum remuneration in the event of loss or inadequacy of profits in any year.

The Executive Director shall function under the supervision, control/directions of the Managing Director of the Company.

The Executive Director will be responsible for New initiatives, Cane development and Human Resource practices of both the sugar divisions Unit-I and Unit-II situated at Bharathinagar and srinivasapura.

The above appointment is subject to the provisions of the Companies Act 1956 and subject to approval of the Central Government, if required and members at the Annual General Meeting.

## EXPLANATORY STATEMENT UNDER SECTION 173 OF THE COMPANIES ACT,1956

#### Item No. 6:

In view of modernization/expansion of the crushing capacity at all operating units and also setting up Co-generation plant, the Board needs authorization to charge, mortgage/hypothecate the assets of the Company as security, it is considered necessary to pass an enabling resolution for securing the requisite finance up to a maximum of Rs. 700 Crores and necessary resolution requires approval under section 293(1) (a) of the Companies Act, 1956 is placed before the members.

None of the Directors of the Company are interested in the resolution.

#### Item No. 7:

Section 293 (1) (d) of the Companies Act, 1956 requires the consent of the Members in the General Meeting for authorizing the Board of Directors to borrow monies (apart from temporary loans obtained from the Company's Bankers in the ordinary course of business) in excess of the aggregate of the paid-up capital and free reserves.

In view of the expansion plans the Company requires additional funds. It is therefore recommended to increase the borrowing powers of the Board of Directors from Rs. 400 Crores to Rs. 600 Crores

None of the Directors of the Company are interested in the resolution.

#### Item No. 8:

In view of the increased activities of the company on account of expansion and setting up of new plants the Board of Directors at the meeting held on 29th June 2009 has thought fit to appoint Sri K. Prakash as Executive Director of the company to assist the Managing Director. The terms of appointment are set out in the proposed resolution. Sri K. Prakash is a B.A graduate and has more than 15 years of business experience. He is also the Chairman & Managing Director of Akhilandeswari Carbon Gases Private Limited. The Board of Directors recommend his appointment in the best interest of the company.

The appointment and payment of remuneration are subject to the approval of the Members of the Company and Central Government if required. Necessary resolution is placed before the Members for approval.

Sri K. Prakash may be deemed to be interested in the resolution as it relates to his appointment and remuneration.

Your directors present their 36th Annual Report together with Audited Financial Accounts of the Company for the year ended 31st March 2009.

#### Review of operations

The unit wise performance is as under:

## Bharathi Nagara Unit

#### Sugar

In this unit, 5.58 lakh tonnes sugar cane was crushed at an average recovery of 8.47% as against 8.63 lakh tonnes at an average recovery of 8.92% in the previous year.

#### **Distillery Division**

During the year under review, 133.07 lakhs litres of industrial alcohol was produced as compared to 158.92 lakhs litres during the previous year. The Sale of industrial alcohol was Rs 40.97 crores as compared to Rs 37.15 crores during the previous year.

#### Co-generation project

The Company has successfully implemented the 26MW Cogeneration Plant at KM Doddi and it has commenced its operations from 2nd April 2008.

The total power generated in the above cogeneration plant during the year was 8.36 Crores units of which 5.99 Crores Units have been exported amounting to Rs. 31.61 Crores,

## Srinivasapura Unit

In this leased facility, 1.47 Lakh tonnes sugar cane was crushed at an average recovery of 8.16% as against 1.35 lakh tonnes (from December 2007) at an average recovery of 10.06% in the previous year.

The reduced availability / diversion of sugar cane, resulted in lower capacity utilization of sugar plant, distillery and co-generation unit, which impaired the working results. The net profit for the year is Rs. 71.46 lakhs. The declaration of dividend has been deferred consequent to the lower profitability and other financial obligation. The management analytical report contains more information on the existing scenario and future prospects.

## Deposits:

All Fixed Deposits and Cumulative deposits matured and claimed as on 31.03.2009 have been paid. At the end of the financial year 19 deposits amounting to Rs 7,41,296/- which were due for repayment remained unclaimed.

## Conservation of Energy, Technology Absorption, Foreign Exchange Earnings and Out Go:

The particulars required to be included in terms of Section 217(1)(e) of the Companies Act, 1956 with regard to conservation of energy, technology absorption, foreign exchange earnings and outgo are given in Annexure forming part of this report.

## Particulars of Employees:

During the year none of the employees in the company are covered under Section 217(2A) of the Companies Act.

#### Directors:

Sri K.N.V. Ramani, Sri S. Srinivasan and Sri. V.K. Swaminathan are liable to retire by rotation in the ensuing Annual General Meeting and are eligible for reappointment.

#### Auditors:

M/s. P.N. Raghavendra Rao & Co., Chartered Accountants, who were appointed as auditors at the previous Annual General Meeting hold office till the conclusion of this Annual General Meeting and are eligible for reappointment.

#### Cost Audit :

The Company has appointed Sri G.I. Srinivasa Murthy, Cost Accountant to audit the cost accounts for the year ended 31.03.2009.
