The Company has diversified itself to the segment of mortgage and real estate loans along with the vehicle loans to three wheelers. The recovery of the Loans of the previous accounts has improved and hence there has been a marginal increase in the profits for the year 2006-07. The financial results above illustrate the same.

FINANCE :

Your Company is availing Cash Credit facility from Punjab National Bank, Vijayawada-1, to the extent of Rs.100 Lakhs. Your Company has further issued secured redeemable Non-Convertible Debentures of Rs.100/- each on private placement basis to the tune of Rs.16.80 Lakhs (Series-Q), Rs.42.60 Lakhs (Series-R) and Rs.49.18 Lakhs (Series-S). While Series-O and Series-P are redeemed in full during the year under review, Series-T is open for subscription on private placement basis.

FUTURE PROSPECTS :

The Company has diversified into mortgage and real estate loans while continuing its presence in the vehicle finance market. Since the real estate sector is on a boom the loans for this sector has good market which the company is trying to capitalise. The Company forecasts good business in this sector. The Company is also contemplating to enter the real estate and construction sector to maximize the returns.
