DIRECTOR'S REPORT TO THE SHAREHOLDERS,

Your Directors hereby present their Tweleyth Annual Report cogether with Audited Balance Sheet as at 31st March.1999 and the Profit & Loss for the period from 1st April 1998 to 31 March.1999.

CORPORATE RESULTS

Your Company's turnover was Rs. 02.63 lacs for the year ended Sist March 1999. as against Rs. 53.93 lacs for the preceding year. The decline in turnover was due to adverse market condition which prevailed throughout the year and the suspension of production.

DIVIDEND

In view of losses incurred during the year and liquidity crunch your directors do not recommend any dividend for the year.

EXPANSION

Since the demand for Trimethoprim. the main product.remained sluggish and the rates were low, the Company could not utilise the expanded capacity throughout the year. Moreover, the main raw material 345 TMBA could not be imported from China due to the continuance of antidumping duty. The indigenous material could not be used due to high cost and hence the low level of sales.

The company has successfully manufactured and marketed CETRIZINE-DI-HYDROCHLORIDE which is anti-allergic. Due to low demand and continuously falling rates, company could not perform as expected. Also the acute shortage of working capital has attributed to a great extent to the very low sales & poor performance of the company.

The management had to suspend the production from April 1998 because of the acute financial crisis and liquidity crunch which compelled the management to retrench the workers and the staff and surrender the power connection.
